**COVID-19 risk level metrics** 

### Five counties at orange warning level

Southern Seven Health the course of the week," Department reports the Illinois Department of Public Health, IDPH, on Friday, Nov. 19, announced that Hardin County will join four other area counties coronavirus disease (CO-VID-19) risk metrics.

Union, Alexander, Johnson, Pope, Pulaski, Hardin and Massac counties are served by Southern Seven Health Department.

Previously warned counties included Union, Alexander, Johnson and Massac.

Pope and Pulaski counties remained stable for the

"While we've seen a slight increase in cases this past week, we haven't seen a huge jump in cases over the community.

Southern Seven Health Department COVID-19 community outreach coordinator Nathan Ryder said in a Nov. 19 news release.

"ICU bed availability that returned to the orange has improved slightly and warning level status on the test positivity rates remain in stable territory, both of which are good signs that we may not see a big rise in cases right before the Thanksgiving holiday."

The amount of new cases per 100,000 people, test positivity percentage metrics and declining ICU bed availability at area hospitals are causing the elevated risk

According to IDPH, an orange designation indicates warning signs of increased COVID-19 risk in

The health department is asking area residents to remain vigilant to slow the spread of the virus.

A warning for new case rate indicates the rate is greater than 50 cases per 100,000 people.

A warning for test positivity indicates that the percentage was above 8 percent from the previous seven-day period.

A warning for ICU availability shows the number of ICU beds has dropped below a 20 percent availability threshold.

The new cases per 100,000 people rate is a unit of measure calculated as a rate to compare the number of cases in large and small counties.

The rate is calculated by dividing the county case count for seven days by county population times 100,000.

This describes the potential number of people who are currently ill and may be infectious in the county.

Union County had 238 potential new cases (based on 40 positive cases) per 100,000 reported. The test positivity percentage for the county was 3.3 percent out of 1,198 tests. ICU avail-

ability was 18.1 percent. Eight different indicators are used to determine a county's designation.

A county is considered at the orange warning level when at least two of the main indicators are going in the wrong direction.

The newly confirmed Union County cases involved two persons under 10, one teen, one in the 30s, three in the 40s and one in the 60s.



### Thanksgiving weather in area

High temperatures on Thanksgiving Day in the regional typically can range from the 30s to the 60s, the National Weather Service office in Paducah reports. Thanksgiving Day is Thursday, Nov. 25.

The weather service reviewed Thanksgiving Day climate statistics on its website.

High temperatures in Paducah typically fall in the 40s, 50s or 60s.

The warmest high on record, dating back to December of 1937, was 74 degrees in 1941. The coldest high was 33 in 1958.

The wettest Thanksgiving was in 1968, with 1.94 inches of rain.

There has been only one Thanksgiving with measurable snow - this occurred in 1950, when 1.3 inches fell.

High temperatures in the 40s are most common in Cape Girardeau on Thanksgiving Day.

The warmest high on record, dating back to 1960, was 72 degrees in 1981. The coldest high was 34 in 1980.

The wettest Thanksgiving on record was in 2010, with 2.43 inches of rain.



### Thanksgiving dinner expected to cost 14 percent more this year

expected to cost 14 percent more this year, with higher turkey prices pulling up that percentage.

The American Farm Bureau Federation's 36th annual survey indicates the average cost of this year's feast for 10 is still affordable at \$53.31, or less than \$6 per person. This is a \$6.41, or 14 percent, increase from last year's average of \$46.90.

The centerpiece on most Thanksgiving tables, the turkey, costs more than last year, at \$23.99 for a 16-pound bird.

That's roughly \$1.50 per pound, up 24 percent from last year, but there are several mitigating factors.

Farm Bureau volunteer shoppers checked prices Oct. 26 to Nov. 8, about two weeks before most grocery store chains began featuring whole frozen turkeys at sharply lower prices.

All the items surveyed saw price jumps from last year, except stuffing, which trends with rising inflation for all

Taking turkey out of the basket of foods reveals a 6.6 percent price increase compared to last year, which tracks closely with the Consumer Price Index for food and general inflation across the economy.

"Several factors contributed to the increase in average cost of this year's Thanksgiving dinner," AFBF senior economist Veronica Nigh

"These include dramatic disruptions to the U.S. economy and supply chains over the last 20 months; inflationary pressure throughout the economy; difficulty in predicting demand during the COVID-19 pandemic and high global demand for food, particularly meat," she said.

Further, "The trend of consumers cooking and eating at home more often due to the pandemic led to increased supermarket demand and higher retail food prices in 2020 and 2021, compared to pre-pandemic prices in 2019."

Illinois Farm Bureau members participated as shoppers for the survey.

In Illinois, prices are slightly higher than the national average, with the cost of a Thanksgiving feast for 10 coming in at \$58.15, a \$4.84, or 8 percent, increase from the national average.

"As the element of inflation comes into play, consumers can still rest assured that there are bargains to be found in their local grocery stores," Illinois Farm Bureau president Richard Guebert Jr. said.

"The food supply is strong, Thanksgiving dinner is steady and plentiful as Illinois farmers work tirelessly yearround to produce affordable products.

The shopping list for Farm Bureau's informal survey included turkey, stuffing, sweet potatoes, rolls with butter, peas, cranberries, a veggie tray, pumpkin pie with whipped cream, and coffee and milk, all in quantities sufficient to serve a family of 10 with plenty for leftovers.

In recognition of changes in Thanksgiving dinner traditions, the Farm Bureau price survey also includes ham, Russet potatoes and frozen green beans in an expanded holiday menu.

Adding these foods to the classic Thanksgiving menu increased the overall cost by \$15.41, to \$68.72. This updated basket of foods also increased in price (up 14 percent) compared to 2020.

Grocers have a large impact on food prices, which vary by region. Yet despite fluctuating costs for consumers, the farmremains a steady 8 percent.

"Farmers have produced the food, but the food supply chain has faced its share of challenges within the past couple years, and it is always adjusting to the needs of U.S. consumers," Guebert said.

"It's important to remember that it takes a lot of hands and a lot of miles to bring the traditional Thanksgiving spread from the farm to the grocery store."

This year's national average cost was calculated using 218 surveys completed with pricing data from all 50 states and Puerto Rico.

Farm Bureau volunteer shoppers checked prices in person and online using grocery store apps and websites.

They looked for the best possible prices without taking advantage of special promotional coupons or purchase deals.

#### er's share of the food dollar WeekNow.com. State school board association leaves national organization

The Illinois Association of School Boards, IASB, Board of Directors voted Nov. 18 in Chicago to terminate the association's membership in the National School Boards Association, NSBA, effective immedi-

ately. The decision follows previous attempts by IASB to initiate changes to the governance structure, transparency and financial oversight

of the national association. IASB said in a news release that it suspended payment of dues to NSBA for 2021-2022 but contin-

ued to work to try to bring about needed changes.

The board stated that it recognizes the need for a healthy national organization that can provide training, federal advocacy, shared resources and networking opportunities.

IASB communicated to NSBA that "IASB no longer believes that NSBA can fill this important role.

In September NSBA sent a letter to President Biden calling for federal assistance, without knowledge or support of its state association members.

With the arrival of autumn and the falling of the leaves, the start of the prescribed fire season was announced recently by the U.S. Forest Service/Shawnee National Forest.

The Forest Service said in a news release that it is planning to implement prescribed fires on 10,000 to 15,000 acres.

Planned burn activities are scheduled to begin at the end of November and continue through September 2022, depending upon weather and burn conditions.

The U.S. Forest Service/ Shawnee National Forest uses prescribed fire as a tool to manage forests and openland habitats in Southern Illinois.

Scientific research has shown that fire helps to restore and maintain oak-hickory forests that support native plants, birds and wildlife.

Prescribed fire is a planned fire that is overseen by professionals. Prescribed fires are performed under specific weather conditions and are designed to mimic fire that historically occurred in the forest.

By bringing fire back into the forest, the U.S. Forest Service/Shawnee National Forest hopes to:

Encourage growth of a diverse array of native plant life.

Ensure oaks remain the

keystone species in our

forests. Oaks provide food for over 100 different animals and is a key habitat for many more. Without fire, shade-tolerant tree species will eventually re-

place oaks. Perpetuate prairie and savanna remnants found within the forest. These remnant plant communities provide habitat for several early-successional songbird species, such as prairie warblers and red-headed woodpeckers. Maintaining open woodland conditions with fire, supports and increases biological diversity.

Protect human property by reducing the amount of down, dead wood in the forest. This will reduce the intensity of future wild-

# Governor signs law which bans 'dark money' in judicial races

SPRINGFIELD – A new law in Illinois aims to ban out-of-state contributions and so-called "dark money" in judicial campaigns by requiring all candidates to disclose the sources of their contributions.

Gov. JB Pritzker on Monday, Nov. 15, signed Senate Bill 536 into law, an omnibus elections bill that makes a number of other changes to the way elections are conducted.

Under the bill, no judicial campaign committee is allowed to accept contributions from any out-of-state source or any person or entity that does not disclose the identity of those making the contribution, except for contributions that are below the threshold for itemizing.

The bill also raises the threshold for itemizing contributions to \$1,000, up from \$500.

It also prohibits people from making or accepting anonymous contributions or contributions made in someone else's name.

Democrats pushed the bill through the General Assembly on the final day of the fall veto session.

It came about partly in response to the 2020 elections in which Supreme Court Justice Thomas Kilbride, a Democrat, was defeated for retention, the first time in state history that a state Supreme Court justice failed to win retention.

During that campaign, a group called Citizens

for Judicial Fairness spent more than \$5.9 million on a campaign to defeat Kilbride, \$4.5 million of which came from Chicago billionaire Ken Griffin, founder of the hedge fund Citadel LLC, according to campaign finance reports. Those types of donations would be unaffected by the new law.

But the campaign also received hundreds of thousands of dollars from so-called dark money groups, including the Judicial Fairness Project, which does not disclose its donors.

Kilbride's own campaign spent nearly \$4 million on his behalf, mainly from labor unions, trial lawyers and the Democratic Party of Illinois.

"Trying to avoid dark money in elections, I think is something that we can all get behind" Rep. Katie Stuart, D-Edwardsville, said during debate on the House floor.

"So the change would stop out-of-state and untraceable money from finding its way into our judicial races to maintain the integrity of those judicial elections."

Republicans, however, argued that it was a partisan maneuver designed to help Democrats protect their current 4-3 majority on the court.

"I can't help but notice that the impetus for great changes in how we conduct elections for the judiciary in the state of Illinois – both the remapping of the Supreme Court (and) the change in campaign finance activities – comes after, for the first time in the history of our state, a Democratic Supreme Court justice lost his retention in the 2020 election," said Rep. Ryan

Spain, R-Peoria.

"So, in my opinion, this is another effort for the majority to change the rules of the game because they don't like the outcome."

A number of other changes in the bill relate to filing deadlines to coincide with the change in the 2022 election cycle when primary elections will be held in June instead of March due to the delay in the release of 2020 census data and the passing of new Congressional district maps.

But the new law also includes other changes, including one giving voters the option of identifying as male, female or non-binary on their voter registration applications so their gender identity can match what appears on their passport or driver's license.

It also allows people to apply for permanent voteby-mail ballots year round. And it requires all polling places to have at least one polling booth that is wheelchair accessible.

Another provision creates a new 15-member task force to "review current laws and make recommendations to improve access to voting for persons with disabilities."

That task force is to submit a report to the State Board of Elections by Aug. 1, 2022, summarizing the laws and resources available to persons with disabilities, and a separate report to the governor and General Assembly by Dec. 15 on recommendations for changes in current law or recommendations for election authorities.

The bill passed both chambers of the General Assembly along partisan lines, 72-42 in the House and 41-17 in the Senate.

The Illinois Department of Public Health, IDPH, has published updated holiday guidance recognizing the protective power of the vaccines.

As experts have advised, vaccinated families can safely return to treasured traditions, while unvaccinated individuals are urged to get their life-saving shot and follow other guidelines regarding travel and gatherings.

"Vaccines work and are our best way to protect ourselves and those closest to us as we celebrate the holidays," IDPH director Dr. Ngozi Ezike said in a news release.

"We've all gone through a lot over the last two years,

and being fully vaccinated gets us one step closer to once again celebrating our cherished traditions. Getting your life-saving shot is the greatest gift you can give this holiday season."

The campaign will appear in every corner of Illinois.

The campaign will reach Illinoisans statewide in both English and Spanish through a variety of traditional and online media channels, including cable, broadcast and connected TV; streaming audio and radio; billboards and bus shelters; digital display and video; print and social media.

Like other coronavirus-related expenses, costs are reimbursable by the federal government.

'The Greatest Gift You Can Give' is part of the state's larger All in Illinois effort, backed by doctors and public health experts, encouraging Illinoisans to protect themselves and their neighbors from COVID-19 by wearing masks in public and getting vaccinated as soon as possible.

### **IDPH offers guidelines for holiday celebrations**

The Illinois Department of Public Health, IDPH, recently issued updated guidance to help people celebrate more safely as the COVID-19 pandemic continues.

"Last year, many people held off getting together with family and friends during the holiday season due to the pandemic," IDPH director Dr. Ngozi Ezike said in a news release

"This year, we have a safe and effective vaccine to help protect against severe illness due to COVID-19 that will allow friends and families to more safely celebrate together.

"Getting vaccinated is the best way to protect yourself, your friends and family, and your community, but there are other actions you can take to celebrate more safely."

IDPH shared the following guidelines:

Travel Safety Considerations

Delay travel until you are fully vaccinated, or wait until you get a booster shot.

If you're not fully vaccinated, test one to three days before and three to five days after traveling.

Travel during off-peak times to avoid crowds.

Drive a private vehicle to reduce exposure to COVID-19.

If using public transportation, try to travel during non-peak times. Masks are required on/in all areas of mass transit.

Guests and Gatherings Keep indoor gatherings small.

Arrange seating and other areas to allow for physical distance.

congregate, such as in the kitchen or at the buffet.

Clean and sanitize the kitchen, bathrooms and other areas used by guests.







### Almost total eclipse of moon seen early Friday

An almost total lunar eclipse which could be viewed in the sky over Union County occurred overnight on Thursday and Friday, Nov. 18-19.

An article headlined "An Almost Total Lunar Eclipse" was posted on the NASA website.

Excerpts from article, written by Molly Wasser and Ernie Wright, follow:

On November 19, 2021 (late evening of the 18th in some time zones), the Moon passes into the shadow of the Earth, creating a partial lunar eclipse so deep that it can reasonably be called almost total.

#### What is an "almost total" lunar eclipse?

A lunar eclipse occurs when the Sun, Earth, and Moon align so that the Moon passes into Earth's shadow.

In a total lunar eclipse, the entire Moon falls within the darkest part of Earth's years until February 8, 2669

shadow, called the umbra. In this eclipse, up to 99.1 percent of the Moon's disk will be within Earth's umbra.

#### How can I observe the eclipse?

The best viewing will be right around the peak of the eclipse, on November 19th (at 3:03 a.m. CST).

This part of the eclipse is visible in all of North America, as well as large parts of South America, Polynesia, eastern Australia and northeastern Asia.

#### Is this the longest lunar eclipse of the century?

Kind of. It's actually the longest partial lunar eclipse in a millennium, clocking in at 3 hours, 28 minutes and 23

There hasn't been a longer partial lunar eclipse since February 18, 1440 (3 hours, 28 minutes, 46 seconds) and it will remain the longest partial lunar eclipse for 648 (3 hours, 30 minutes, and 2 seconds).

There will be a longer total lunar eclipse on November 8, 2022.

This is a long eclipse for two main reasons: 1) The Moon's orbital speed and 2) The near-totality of the eclipse.

First, the Moon's orbit around the Earth is not a perfect circle, and the Earth is off-center within the orbit so sometimes the Moon is closer to the Earth and sometimes it is farther away.

This change in distance impacts the Moon's orbital speed. Closer to the Earth, the Moon moves faster, while further away, it travels more slowly.

Right now, the Moon is near its farthest point in its orbit around the Earth and thus, moves slowly through Earth's shadow.

Second, since this eclipse is almost-total, the Moon spends a longer amount of time in the Earth's umbra than it would in a "more-partial" eclipse.

Her service was beautiful and upbeat though, and the love and joy for her was very evident. I pray her family think of those special moments with her in the coming days.



### **IDPH recommends** booster doses for all eligible individuals

of Public Health, IDPH, following the Food and Drug Administration's decision to open COVID-19 booster shots to all, on Friday, Nov. 19, announced that it is recommending anyone 18 years and older to get a COVID-19 vaccine booster dose.

IDPH recommends that people get their booster dose six months after receiving their second Moderna or Pfizer-BioNTech vaccine, or two months after receiving the onedose Johnson & Johnson

"For continued, ongoing protection, we are urging everyone who is eligible to get a booster dose of COVID-19 vaccine to get one," IDPH director Dr. Ngozi Ezike said in a news release.

"Scientific and medical experts have reviewed the data and found booster doses are beneficial. While we need more people who are completely unvaccinated to get their first doses, we cannot risk losing some of the protection the vaccines have already provided due to waning immunity."

Early data show that the vaccines effectiveness against COVID-19 infections is decreasing over

cases of COVID-19 in the state increased 25 percent from the previous week. IDPH was reporting a

total of 1,763,866 cases, including 26,227 deaths, in 102 counties in Illinois.

Of Illinois' total population, approximately 67 percent had received at least one COVID-19 vaccine dose and almost 61 percent of Illinois' total population was fully vaccinated, according to data from the Centers for Disease Control and Prevention, CDC.

All data are provisional and will change, IDPH reported.

The Illinois Department is likely due to the combination of decreasing protection as time passes since getting vaccinated, as well as the greater infectiousness of the Delta variant.

> Getting a booster shot is not uncommon. This happens every year with seasonal flu vaccine.

> IDPH advises that while people should get the same type of vaccine for both their first and second doses, the CDC has said mix and matching vaccines for booster shots is allowed.

> For example, if you received two doses of the Moderna vaccine, you may opt to get a Pfizer-BioNTech vaccine for your booster dose.

Or if you received the one-dose Johnson & Johnson vaccine, you may choose Moderna for your booster dose.

You just need to wait six months after your second dose of Pfizer-BioNTech or Moderna, or two months after your one dose of Johnson & Johnson vaccine.

Individuals can contact their health care provider or visit www.vaccines.gov to find a nearby location to

### Illinois unemployment falls to 6 percent By Peter Hancock **Capitol News Illinois** phancock@capitol-

SPRINGFIELD – The Illinois unemployment rate fell two-tenths of a percentage point in October to 6 percent as employers added 40,900 jobs during the month, the Illinois Department of Employment Security and the U.S. Bureau of Labor Statistics said Thursday, Nov. 18.

According to the preliminary data, the industry sectors with the biggest job gains during the month were professional and business services, which added 17,700 jobs; leisure and hospitality, which added 8,400 jobs; and trade, transportation and utilities, which gained 7,700 jobs.

Those gains were partially offset by job losses in the information sector and educational and health services.

"Today's data are positive markers indicating a continued recovery to our economy and labor market," Deputy Gov. Andy Manar said in a statement.

"IDES continues to work with employers and jobseekers to assist matching businesses with those looking to reenter the workforce or make career changes."

Department of Commerce and Economic Opportunity director Sylvia Garcia said the numbers showed that Gov. JB Pritzker's administration's economic recovery policies during the pandemic have had positive results.

"Monthly labor reports continue to prove that our administration's investments to stimulate small businesses, deliver workforce development grants and jumpstart community and capital development projects across our state are paying dividends," she said in a statement.

The October jobless rate in Illinois was 1.4 percentage points higher than the national rate, but it was 2.1 percentage points below where it was a year earlier.

Compared to a year ago, the number of nonfarm payroll jobs was up by 190,300, ed defrost times. with gains showing up in nearly all major industries.

The leisure and hospitality sector, which was hit

hardest by the pandemic, has added back 60,800 jobs while professional and business services have gained back 50,000 jobs. The trade, transportation and utilities sector has add-

ed 37,200. Financial activities, which is still down by 5,200 jobs, was the only industry group that reported job losses over the year. Total nonfarm payrolls were up 3.4 percent over the year in Illinois and 4.1 percent in

Along with the October jobless figures, the Bureau of Labor Statistics made a significant downward adjustment to the September unemployment rate, lowering it to 6.2 percent from the preliminary estimate of 6.8 percent.

That was due to an adjustment BLS had made in January to the way it estimates the size of a state's labor force in order to account for the impact of the pandemic.

IDES said in a news release that the adjustment inadvertently created "distortions" to statewide labor force estimates for Illinois, Michigan, Indiana, Ohio and Wisconsin for January and all subsequent months through September 2021.

BLS said the distortions were only recently identified after Illinois and another state in the agency's East North Central Division raised concerns about their monthly 2021 labor force estimates.

The BLS has found that distortions to the Illinois labor force estimates are limited to January-September 2021.

### Thanksgiving dinner: tips shared for safely handling main course

Southern Seven Health chicken since 2005, but Department says there are few things more satisfying at Thanksgiving than a well-cooked turkey.

But a wrong turn in preparation could mean a dinner followed by a food-borne

Symptoms of food poisoning can be anywhere from mild to very serious.

The most common symptoms of food poisoning are an upset stomach, stomach cramps, nausea, vomiting, diarrhea and fever.

To prevent a food-borne outbreak from spoiling your family traditions, Southern Seven Health Department offers some basic steps from the Centers for Disease Control and Prevention, CDC, to safely handle your main course.

Start by thawing your turkey properly. Never thaw your turkey by leaving it out on the counter.

A thawing turkey must defrost at a safe temperature. This can safely be done in the refrigerator in a container, in a leak-proof plastic bag in a sink of cold water (change the water every 30 minutes) or in the microwave following the microwave oven manufacturer's instructions.

Check your turkey's packaging for recommend-

turkey. Federal food safety mometer to make sure the advice has recommended stuffing's center reaches

some habits are hard to break.

A 2020 survey found that 78 percent of participants reported washing or rinsing their turkey before cooking. Old recipes and fam-

ily cooking traditions may keep this practice going, but it can make you and your family sick.

Poultry juices can spread in the kitchen and contaminate other foods, utensils and counter tops.

Use a separate cutting board for raw turkey; never place cooked food or fresh produce on a plate, cutting board or other surface that previously held raw turkey.

Wash cutting boards, utensils, dishes and counter tops with hot soapy water after preparing turkey and before you prepare the next

And wash your hands with warm soapy water for 20 seconds before and after handling any contaminated items, including the turkey.

Don't forget the stuffing. Cooking stuffing separately from the turkey in a casserole dish makes it easy to be sure it is thoroughly

If you cook stuffing in the turkey, put the stuffing in the turkey just before cooking

With either cooking Do not wash or rinse raw method, use a food theragainst washing turkey or 165 degrees F.

Bacteria can survive in stuffing that has not reached 165 degrees F and may then cause food poisoning.

If you cook stuffing in the turkey, wait 20 minutes after taking the bird out of the oven before removing the stuffing; this allows it to cook a little more. If you oven bake your

turkey, cook it thoroughly by setting the oven temperature to at least 325 degrees F. Place the completely

thawed turkey in a roasting pan that is 2 to 2 1/2 inches

Use a food thermometer to make sure the turkey has reached a safe internal temperature of 165 degrees F.

Check by inserting a food thermometer into the center of the stuffing and the thickest portions of the breast, thigh and wing joint.

Even if your turkey has a pop-up temperature indicator, you should still use a food thermometer to check that it is safely cooked.

Refrigerate leftovers at 40 degrees F or colder as soon as possible and within two hours of preparation to prevent food poisoning.

Slice or divide big cuts of neat, such as a roast turkey. into small quantities for refrigeration so they can cool quickly. Reheat all leftovers to at least 165 degrees F before serving.




