## **City of Anna seeks News** full count in Census **Notes**

working hard to ensure that everyone is counted during the 2020 U.S. Census.

City administrator Dori Bigler said the goal is to ensure that everyone in the Union County community is counted in the Census.

The city has partnered with the U.S. Census Bureau to support the 2020 Census.

A message posted on social media by the city declares: "As a partner, we'll be working to ensure that our community is accurately represented."

The city has received grant funding through the Illinois Public Health Association which will be utilized to support the most accurate Census count possible.

Last fall, Gov. JB Pritzker and the Illinois Department of Human Services, IDHS, announced that

Anna city officials are 30 local community and government associations throughout the state would receive a combined \$20 million in funding.

> The funds were being allocated to maximize Illinois' success in the 2020 Census.

> The 30 organizations will serve as regional intermediaries for the 2020 Census. The intermediaries then were to select local organizations within their region to make additional grants.

> State officials said that the selection of grant recipients by the regional intermediaries was designed to ensure that funding would go directly to organizations that are on the front lines and best equipped to connect with the people of Illinois in urban, rural and other hard-to-reach communities.



"My message to Illinoisans is that the Census is one of the best ways for your voice to be heard," Gov. Pritzker said in a news release when the grant funding was announced.

"My administration is committed to ensuring an accurate Census count so that Illinoisans get both the representation and funding for critical services that they deserve."

Last year, the governor signed Executive Order 19-10 to ensure an accurate Census count in all communities throughout Illinois.

The order established a new Census office. A bipartisan Census advisory panel is guiding the work of the office.

State and local officials note that Illinois' final Census count is consequential.

An undercount of residents could diminish the state's proportional share of federal funding for critical services and programs.

The number of seats Illinois has in the U.S. House of Representatives for the next 10 years also will be promote the Census.

Bigler said that an Anna Census complete count committee has been set up. The committee includes representatives from the city, schools, health care agencies, other agencies and the community.

The committee has had its first meeting and will continue to meet to chart a course to ensure the success of the 2020 Census in Anna.

Bigler said that community events are slated to be a part of the local Census effort.

Plans also call for a computer to be made available at Anna City Hall which will be utilized to help members of the community to fill out their Census forms.

## **Important Dates**

The U.S. Census Bureau released the following "Important Dates" for the 2020 Census on its website.

Jan. 21: The U.S. Census Bureau started counting the population in remote Alaska. The count officially began in the rural Alaskan

village of Toksook Bay. March 12-20: Households will begin receiving official Census Bureau mail with detailed information on how to respond to the 2020 Census online, by phone or by mail. March 30-April 1: The Census Bureau will count people who are experiencing homelessness over these three days. As part of this process, the Census Bureau counts people in shelters, at soup kitchens and mobile food vans, on the streets and at non-sheltered, outdoor locations such as tent encampments. April 1: Census Day is observed nationwide. By this date, every home will receive an invitation to participate in the 2020 Census. Once the invitation arrives, you should respond for your home in one of three ways: online, by phone, or by mail. When you respond to the census, you'll tell the Census Bureau where you live as of April 1, 2020. April: Census takers will begin visiting college students who live on campus, people living in senior centers and others who live among large groups of people. Census takers also begin conducting quality check interviews to help ensure an accurate count. May-July: Census takers will begin visiting homes that haven't responded to the 2020 Census to help make sure everyone is counted. December: The Census Bureau will deliver apportionment counts to the president and Congress as required by law.

# **Southern Seven Health Department** shares update on Novel Coronavirus

Department reported on Tuesday, Feb. 11, that the Centers for Disease Control and Prevention, CDC, had confirmed the 13th case of Novel Coronavirus in the United States.

Southern Seven reported that the CDC on Monday, Feb. 10, had "confirmed another infection with 2019 Novel Coronavirus (2019nCoV) in the United States that was detected in California.

'The patient who was under a federal quarantine order recently returned from Wuhan, China, where an outbreak of respiratory illness caused by this novel coronavirus has been ongoing since December 2019.

"This brings the total number of 2019-nCoV cases in the United States to 13.

"CDC is conducting a thorough contact investigation of the person who has tested positive to determine

Department also reported that on Friday, Feb. 7, the Illinois Department of Public Health, IDPH, was able to bring testing for 2019 novel coronavirus (2019-nCoV) online, making Illinois the first state to do so.

Once specimens from individuals are received at the Chicago IDPH laboratory, test results are typically available within 24 hours.

IDPH is in the process of bringing testing for 2019nCoV online in its Springfield and Carbondale laboratories.

The ability to do this testing means we will be able to detect any new cases of novel coronavirus earlier and prevent any possible spread," said IDPH assistant director Evonda Thomas-Smith.

'We understand there is concern about this new virus, which is why having test results back quickly can help reduce some of those concerns."

On Wednesday, Feb. 5, CDC, began shipping 2019nCoV laboratory test kits to select qualified U.S. and international laboratories.

As of Feb. 11 in Illinois, two residents had tested positive for 2019-nCoV, while 44 test results have come back negative.

Legislation signed by Gov. JB Pritzker clarifies an existing state law and makes it clear that employees own their tips.

The law, which took effect at the beginning of this year, amends the Illinois Wage Payment and Collection Act.

The law states that gratuities are the property of employees, and that their employers cannot retain

## **State police** note activities

Illinois State Police District 22 has released a review of activities for the month of January.

The district includes Union, Johnson, Pope, Massac, Hardin, Pulaski and Alexander counties.

District 22 officers responded to 85 calls for service.

Officers issued 583 citations and 1,550 written warnings.

Four motorists were arrested for driving under the influence, DUI.

Sunshine has been a rare commodity during the past week in the Union County area. Cloudy, cold and damp conditions have been common.


High temperatures during the period of Feb. 4-10 ranged from 34 to 61 degrees. The low for the period was 26.

The Illinois Department of Financial and Professional Regulation on Feb. 7 granted medical cannabis dispensing organizations the ability to remain open until 10 p.m. to make medical cannabis sales.


The department provided additional guidance to dispensaries that have both a medical and adult use license to ensure they prioritize serving medical cannabis patients as required by state law.

Since the beginning of the medical cannabis program, medical cannabis sales have been limited to between the hours of 6 a.m. and 8 p.m., while adult use sales are permitted by law until 10 p.m.

To address this, the Division of Professional Regulation issued a variance to the medical cannabis administrative rules, effective immediately, to expand the hours during which medical patients and their caregivers can purchase cannabis.

The division also issued guidance to dispensaries on measures they can take to prioritize serving medical cannabis users as required by Section 15-15(i) of the Cannabis Regulation and Tax Act.

Medical cannabis users who think their needs are not being met can file a complaint on the IDFPR website. The website can be found at idfpr.com.



Jennings recently beat two other Jeopardy! legends, Brad Rutter and James Holzhauer, to win \$1 million and the GOAT (Greatest Jeopardy! Player of All Time) title.

It was a prime-time, bestof-seven event in which two games were played each night with earnings totaled to choose that day's winner.

It took Jennings just four matches to claim the title against fierce competitors. Rutter holds the record for the highest total winnings of any American game show

contestant with \$4,688,436, followed by Jennings and Holzhauer. Holzhauer had a 32-game winning streak in 2019 and holds the top 16 single-game scores for the game.

A Seattle native, he spent his childhood in Korea and Singapore, where his father was an attorney and young Ken faithfully watched the game show on Armed Forces Network.

While working as a software engineer in 2004, Jennings got a call that would change his life.

He would appear on his beloved Jeopardy! in June. The tech wizard resorted to some old-fashioned methods: flash cards and hours of study, to prepare for his appearance. It worked.

One victory led to another and he reigned as champion for six months, winning 74 games and earning \$2.52 million in regular season play: both record-breaking feats for American game shows.

He also holds the record for the highest percentage of correct responses, a remarkable 35.9 percent.

He has since gone on to host other game shows and appear in advertisements for national companies.

Jennings has also found a new career: best-selling author. He has a dozen books to his credit.

Prolonged period of wet weather in region

enced a prolonged period of wet weather for more than two years.

The National Weather Service office in Paducah reported on its website that the wet pattern began in January 2018 and is likely to continue during February 2020.

"Someone must have broken the faucet, as our region has continued to get drenched on a constant repeat cycle over the past two years," the weather service observed.

February is likely to become month number 22 out of the past 26 with above normal precipitation in Paducah.

'We have high confidence that February will finish with above normal precipitation," the weather service reported on Feb. 6. As of Feb. 6, only 0.70 of an inch of precipitation was needed for the month to have above normal precipitation.

Since January 2018, above average monthly precipitation departures in Paducah have ranged from a low of 0.03 of an inch in March 2018 to a high of 6.51 inches in February 2019. Below average monthly precipitation departures ranged from a low 0.23 of an inch in August 2018 to a high of 3.43 inches in September 2019. In Union County, total precipitation has exceeded 60 inches for the past two years. Records kept by local weather observer Dana Cross in Jonesboro showed

June was the wettest month in 2019 in Union County, with a total of 9.36 inches of rain.





()In Bible times, when an individual owed another a sum of money, they would take a stone, or piece of pottery, and engrave the amount that was owed on the face of the stone or pottery, and the engraving remained as long as the amount was owed. But when the sum was paid in full, wax would be melted and poured over the face of the stone and the engraving would be filled in - or "covered up," and the debt was settled. From that cultural background, the Psalmist says, "Blessed is the man whose sin is covered" (Ps. 32:1-2). Sin is a debt I owe and as the song says, a debt I could not pay. Thus, Jesus said in Matt. 6 how we are to forgive men their debts. So, sin is a debt. It's like an engraving on the face of the stone, but with forgiveness, the debt – the engraving – is covered over - not with wax, but with the very blood of Jesus! (Rom. 5:9): "Being therefore justified by His blood, we shall

be saved from the wrath of God through Him." So, first of all, sin – being forgiven – is like having my sins (the debt I owe to God) engraved on the face of a stone. But with forgiveness, the blood of Jesus is poured over the face of the stone and makes its way into the engraving and covers it up, so that I owe the debt of my transgression against God no more.

Furthermore, in Isaiah 1:18, the Bible says, "Come now, and let us reason together, saith the Lord. Though your sins be as scarlet, they shall be as white as snow. They shall be as wool." In this passage, sin is set before us as a stain, and forgiveness as the stain being removed. Now, think about that stone in Bible times that would represent the debt owed. So first of all, my transgression is engraved on the face of the stone, second, it is covered over by the blood of Jesus - but wait: even though the engraving has been filled & covered over by the blood of Jesus, the stain is still there. You can see where the engraving has been covered over by the crimson blood of Jesus, and there's still a reminder of the fact that at one time, my life was not right with God. So, with this idea of removing the stain, using a stone that has been covered over, now you have the idea of God not only covering over the engraving with the blood of Jesus, but He now - because of His unsurpassed love - rubs the face of the stone absolutely smooth so that there's no longer any engraving covered over by blood, as if there had never been anything engraved there to begin with! That is incredible and that is the kind of forgiveness that God makes available to everyone who is obedient to Him!



# **'Building Main Street,** not Wall Street'

Future determined by decisions made today By John A. Newby

Truly Local shopping isn't just a nice thing to do to show local spirit. Truly Local shopping in the future may very well be the difference between whether your community grows economically or withers on the economic vine.

To be clear, Truly Local isn't the same as just shopping local, all local shopping isn't created equal. Truly Local is described as locally owned and operated; this on occasion includes national chains that are locally owned.

With the increase of big boxes, national chains, Wall Street or out-of-town owners and online shopping opportunities, many local community governments are finding it increasingly more difficult to make their local fiscal budgets stretch to cover their basic needs. In fact, many are already in severe financial straits.

The term "unintended consequences" could very well have been coined to convey the situation many communities find themselves in today or will find themselves in the near future.

The courtship of big boxes and chains might be viewed as a necessary evil that communities must attract to appear viable. By bringing these big boxes and chains to the community, it can indeed create new jobs, increase the quality of life for residents and provide a greater variety of goods and services that we all enjoy.

While the benefits can be great, we must realize this also comes with high risk as well. The greater the saturation of big boxes and chains, the greater long term economic risk to our communities. One might ask, how can this be?

Very simply, the more money each of us spends with these big box, chain and out of town owners; the bigger the drain on our local budgets as a greater percentage of those dollars we are spending leave our community, never again to return.

Studies show that dollars spent at locally owned businesses are 3 to 7 times more valuable, as they are recirculated multiple times throughout the community in lieu of being sent to some far off corporate headquarters.

It is those same dollars leaving our community that otherwise would fund our police, fire departments, city government, water department, road department, parks and recreation and so forth. Bottom line, fewer dollars equate to fewer or less than desirable services. How can communities balance sending their dollars to Wall Street in lieu of growing their own Main Streets?

As is the case with most things in life, it is all about balance. Having these big boxes, chains, Wall Street and out-of-town owned businesses can initially be beneficial to the overall growth of a community.

The bigger issue arises when communities in their haste, vigorously court these big boxes, chains and Wall Street organizations at the expense of organically growing their local business base from within.

We must not forget that small businesses, mostly locally owned, employ the majority of all workers across the country. We must attend to that base as well. Communities must find the resolve to expend equal attention and resources on their local business, innovation and entrepreneur base. Nurturing their startups will ultimately create the balance to weather the pending economic storm clouds of retail; along with the rapidly shifting shopping habits that are changing right before our eyes. With the rapidly shifting retail and consumer habits, it is imperative that communities have these critical conversations. It is also critical that they find ways to stimulate local entrepreneurship and innovation. It is imperative that they find ways to keep a greater percentage of their consumer spending local. The younger generations are leading us rapidly towards an experiential economy where it isn't about sameness, but about making dining and shopping an experience. This spells local in every way. These aren't just nice discussions to have; the economic and vital future of every community under 100,000 is in danger of slowly being dismantled by the winds of economic change. We are sure of one thing; Wall Street cares little about our communities, unless of course, how it can extract more local dollars that boost their bottom lines. The future of our communities are certainly in our hands, and our hands only. Whether we win or lose tomorrow will be determined by the hard decisions we make today. Hopefully our communities will make those decisions based on long-term growth and not just shortterm satisfaction. John A. We motored to Carbondale to attend a reception for a new exhibit which is on display at the University Museum. As the name might imply, the museum is on the campus of Southern Illinois University Carbondale, which, by the way, is our alma mater.

The exhibit, which is titled "Women's Voices," features the works of 23 female artists. Some of those artists call Union County home. And many of those who went to the reception also call Union County home.

The art works which are on display in the exhibit are, well, wondrous, colorful, imaginary, thought-provoking... let's say a pot of gold at the end of a rainbow of creativity. Goodness, that was way more philosophical than my simple little mind can handle.

"Women's Voices" is on display through March 21. Check it out. You might even see an armadillo.

Saturday morning involved the usual chores which are part of your writer's life. That's another story.

Then it was off to the Civil War Weekend at the Anna Arts Center. Would have liked to have spent more time listening to the folks who were guest speakers at the event.

Saturday afternoon, yours truly headed to Giant City State Park, which is just up the road, in the suburbs of metropolitan Makanda. A program titled "Snake Road: A Southern Illinois Treasure" was scheduled at the visitors center at the park. The program was presented by biologist John Palis.

Snake Road is located in Union County, just north of Wolf Lake. I learned Saturday that Snake Road likely is the only thoroughfare on the entire planet which is closed to protect snakes. For all we know, Snake Road could well be the only place in the entire universe which is closed to protect snakes.

Snake Road is closed twice each year, in the spring and in the fall, so critters like snakes can migrate to find a cozy place to spend the winter. Makes me kind of wish I could migrate to someplace else for the winter, too.

Palis said he has made 177 visits to Snake Road and has recorded some 3,845 snake sightings. That would be much more successful than yours truly and our daughter experienced during a visit to Snake Road on a sweltering September afternoon in 2019. We saw a toad. And a spider. No snakes. It was suggested that we might try again on a milder day in April, or maybe October.

Sunday afternoon, it was back to the visitors center at Giant City State Park, where a program about the Underground Railroad in Southern Illinois was slated. The Other Half and yours truly made another date of it.

And so did a lot of other folks, too. A standing room only audience was on hand. I'm guessing somewhere in the range of 60, or more, people. It was good to see so many folks interested in history, especially the history of

We do live in a special place. Programs like those presented last weekend at Giant City State Park help us to remember how special Southern Illinois truly is.

By the way, a number of programs are presented during the course of the year at Giant City State Park. You might want to check out the schedule, which you can find online.

As you can tell, I didn't have much time to be bored
