Anna city officials frustrated by street issues

Anna city officials again have voiced their frustration about a lack of progress on several street projects in the Union County com-

The concerns were voiced at a regular meeting of the Anna City Council which was held Tuesday evening, Sept. 18. The meeting was at Anna City Hall. One of the concerns

about streets which was discussed at the meeting focused on flooding which occurs in the 500 block of East Vienna Street. The location frequently floods when heavy rains fall on the Union County area.

Flooding at the location occurred less than 24 hours after the city council's Sept. 18 meeting.

Heavy rain fell on the Union County area at around midday on Wednesday, Sept. 19.

At around noon on Sept. 19, the Union County area was under an urban and small stream flood advisory which had been issued by the National Weather Service office in Paducah.

The weather service reported at 11:56 a.m. that heavy rain was expected to cause urban and small stream flooding in the advisory area.

At the time, the weather service reported that 1.5 inches of rain had fallen quickly in the Union County area. Another inch of rain was possible.

Flooding at the East Vienna Street location has been a concern for city officials for a number of years.

City officials said they have met with State Rep. Terri Bryant, R-Murphysboro, to voice their concerns about the situation.

Vehicle, pedestrian safety around railroad tracks promoted by Illinois State Police District 22

year, Illinois State Police District 22 is partnering with local, state and federal agencies to promote vehicle and pedestrian safety around railroad tracks and trains during Rail Safety Week, which is taking place Sept. 23-29.

To promote rail safety awareness and education and prevent injuries and fatalities, District 22 commander Capt. Michael Alvey has planned enforcement details throughout the week at various railroad grade crossings. Union County is in District 22.

Drivers and pedestrians

For the fifth consecutive who disobey the laws associated with railroad grade crossings and railroad property will be cited, Alvey said in a news release.

In addition to enforce-

ment efforts, the Illinois

State Police also are com-

mitted to changing behavior through education. Officers will be distributing literature to the public that contains rail safety

information.

"When crossing railroad tracks, motorists must always obey the law and be aware of your surroundings," Alvey stated in a news release.

"Please remember, it

your vehicle on the railroad tracks and anywhere within the highway-rail grade crossing.

"Highway-rail grade crossings are typically marked by white stop lines located on the pavement in advance of the crossing, and if not marked by white stop lines, the highwayrail grade crossing extends from protective gate arm to protective gate arm.

"Please also remember it is against the law for pedestrians to go around a protective gate or disobey warning lights or bells."

In 2017, there were over

is against the law to stop 2,100 railroad crossing collisions involving motor vehicles nationwide, which resulted in over 800 injuries and over 270 fatalities.

> In 2017, there were over 100 railroad crossing collisions in Illinois involving motor vehicles; these collisions resulted in 29 injuries and 25 fatalities.

> In addition, there were 46 trespassing incidents on railroad property in Illinois, which resulted in 26 injuries and 20 fatalities.

In 2017, Illinois ranked second in the nation in grade crossing fatalities and seventh in the nation in trespassing fatalities.

Illinois unemployment rate falls to 4.1 percent in August

of Employment Security, IDES, reported that the state's unemployment rate fell to 4.1 percent in August.

Nonfarm payrolls decreased by 5,200 jobs, based on preliminary data provided by the U.S. Bureau of Labor Statistics and released by IDES.

The July job gain was revised down slightly from its initial report to show no growth.

Job growth moderated in the June to August period posting average monthly

The first Illinois State Fair was held Oct. 11-13, 1853, in Springfield. The state fair again was held in Springfield in 1854. After 1854, the state fair was held annually at different locations throughout the state. In 1893, the state fair returned to Springfield permanently.

The Illinois Department gains of 4,000 jobs over this three-month period, less than the prior three-month average monthly gain of 8,300 jobs between May and July.

In August, the three industry sectors with the largest over-the-month gains in employment were professional and business services; trade, transportation and utilities; and financial activities.

The industry sectors with the largest payroll declines were leisure and hospitality, education and health services, and construction.

The state's unemployment rate was 0.2 of a percent higher than the national unemployment rate reported for August, which held at 3.9 percent.

The number of unemployed workers decreased 1.3 percent from the prior month to 268,700, down 16.9 percent over the same month for the prior year.

The city has voiced its appreciation to Bryant for the work she has done related to the street issues.

Basically, city officials said at last week's council meeting, there is no answer to solving the flooding problem.

City attorney John Foley said that resolving the flooding situation should not be Anna's responsibil-

"It shouldn't be the city's duty to fight that fight," Foley said. "If it's a state highway, it's their jurisdiction."

Discussion at last week's meeting hinted that the situation could end up in litigation.

Frustration also was voiced about plans for improvements along South Main Street, from the fourway stop in downtown Anna, to the City of Jones-

Major work was done by the state during the summer at the four-way stop.

The city thought it had entered into an agreement last fall with the state for the improvement work.

The city council approved a resolution in support of Hadley's Haven, which is an all-inclusive playground project. The project is planned at the Anna City Park.

City administrator Steve Guined reported that work continues on the final steps in the closing of the city's municipal landfill.

The landfill was closed in the mid-1990s. The landfill site is located along Kaolin Road, north of Anna.

The city is hoping to obtain final closure status from the Illinois Environmental Protection Agency, IEPA, by the end of 2018.

Motor fuel tax funded street maintenance work tentatively is planned during the second or third week in October. The city has allocated \$154,000 for the work.

A-J School Board discusses current, future projects

The Anna-Jonesboro Community High School District No. 81 Board of Education monthly meeting, held Sept. 17, started out with a public hearing for the 2018-2019 school district budget.

District superintendent Rob Wright walked those in attendance through the highlights of the budget, reporting the district's finances to be in good shape, anticipating that they will be able to reach their goal of 220 days cash on hand. The board approved the budget with all members in attendance voting yes.

The regular meeting began with the consent agenda, which approved board meeting minutes, bills for payment and financial re-

A-JCHS Student Council members Jaci Woodward and Jenna Watkins gave an update about the arrangements for homecoming, including this year's theme and the nominees for the homecoming court.

Items of interest from the teachers included an update from the counseling office, whose Freshman Academy program has been meeting with A-J freshmen to ascertain academic, social and emotional risk factors to provide support for at-risk students.

They've also been working to identify students of all grade levels with a history of failing grades in order to provide them further academic support.

Faculty have also begun a new career-planning program with freshmen, with the plan to expand the program to sophomores and juniors in the spring.

A trip with students to SIU Day was planned, with additional college campus visits possible in the future.

Additionally, it was announced that A-J teacher Grace Darmour-Paul was awarded a \$625 grant through the Illinois Retired Teachers Association to provide her Spanish classes with Spanish language nov-

Hannah Maze's government classes have begun a study on the debates surrounding the controversial issues of the times.

Students were assigned

to take a stance on a heated topic and write a letter to their representative expressing their views.

Principal Brett Detering discussed the implementation of a new state law that guarantees that all students can have access to school lunch regardless of their ability to pay.

Detering indicates that A-JCHS already had a similar rule in place before the law was passed, meaning minimal change for school

Detering also discussed safety drills conducted at the school, including a fire drill conducted on Sept. 5, which was reported to have gone smoothly. Additionally, an active shooter drill was scheduled for Thursday, Sept. 20.

It was also reported that the hiring of a new guidance counselor for the school year has helped with implementing the Freshman Academy program and in identifying of at-risk students, and the new Friday grade check keeps students and parents apprised of academic progress.

Superintendent Wright discussed an update of the facilities use agreement with the Union County Soccer League, as well as an update on the school's five-year plan, a draft of which should be ready for the next board meeting.

Wright also discussed a possible future building project to replace the floor in the gym, and the pros and cons of using wood for the replacement versus a synthetic material.

Following a closed session, the board voted and approved the 2018-2019 budget as well as a contract for speech services.

Wright also discussed a new program proposed by Ameren that will allow the school to replace their fluorescent lights with LED lights for \$1 per bulb. Wright explained that the lights would eventually pay for themselves in energy savings. However, the total cost for replacing the school's approximately 3,600 bulbs would also include installation and disposal of the old bulbs.

The next A-JCHS Board of Education meeting is scheduled for Oct. 15.

Registration begins at 9 a.m. Group photographs will be taken at 10 a.m.


The pageant is open to girls ages 5 to 15 who are Union County residents.





The Preaching Pen A Relationship With God Is it really possible for us to have a personal

relationship with God? Just as many apostles and prophets enjoyed a very close walk with Jehovah, we also can enjoy and benefit from a close personal walk with our God.

James 2:23 says, "And the scripture was fulfilled which saith, Abraham believed God, and it was imputed unto him for righteousness: and he was called the Friend of God." True faith and works are inseparable. In the offering of Isaac we see a solid demonstration of the faith of Abraham. Abraham was justified by his faith, which caused him to act (Biblical faith is always obedient faith!). His obedience identified him as the friend of God. Abraham enjoyed a special relationship with God - was the friend of God, and we can have that kind of relationship with God, too, when we do what Abraham did - allow our faith to be shown by our works.





90 percent of readers say their community newspaper keeps them informed

vspape SPRINGFIELD, Ill. - Ninety percent of the more than 1,000 people responding to the National Newspaper Association's 2018 readership survey said that their community newspaper informs them. And 73 percent said that their hometown paper provides valuable local shopping and advertising information. The poll was conducted for NNA by Susquehanna Polling and Research, which is based in Harrisburg, PA.

In addition, 64 percent of survey respondents said they read a community newspaper either in print or online, which is a small decline from last year's survey. When it comes to advertising, readers are most likely to trust and respond to ads they see in their community newspaper.

According to the survey, community newspapers rate as the most popular advertising medium when it comes to making purchasing and shopping decisions at local merchants, cited by 24 percent of respondents. Other less popular ad platforms include direct mailings, 18 percent, social media platforms; 16 percent, and in-store promotions; 13 percent. Readers of community newspapers tend to rely on newspapers even more, cited by 34 percent: far and above the most popular answer

NNA has continually fought to keep public notices in newspapers, as one way to keep an eye on what the government is doing with taxpayers' money. According to the survey, respondents rated the importance of access to public notices a mean score of 5.72 on a 7-point scale, including a combined 80 percent who give a high score of five, six or seven. Even non-readers of community newspapers agree that access to public notices is important, with a mean score of 5.66.

As most publishers know, the people who read newspapers are the ones who are most likely to vote. When it comes to the coming mid-term elections, 84 percent of community newspaper readers are very likely to vote this year, compared with only 61 percent of non-readers. Plus, 77 percent of community newspaper readers say they voted in the last election in their local community, compared with only 61 percent of non-readers. This shows that readers of community newspapers tend to be more politically active than non-readers. In fact, according to the survey, 86 percent of the respondents said they were either very likely or somewhat likely to vote in the next election.

For those newspapers working to get more political advertising in the coming elections, the survey notes that community newspapers are cited by respondents as not only the most common go-to source to learn about political candidates running in local elections at 65 percent very or somewhat often, but also the most trusted with a 4.38 mean score on a 7-point scale. In comparison, other less-popular sources of information to learn about local candidates include national network TV news,

cited by 57 percent, cable TV news programs; 47 percent, talk radio; 36 percent; and social media platforms, 33 percent. Additionally, 81 percent of community newspaper readers rely on local newspapers to learn about local candidates, far more than any other source. On the issue of trust, even non-readers of community newspapers trust community newspapers more than other sources, rating their overall trustworthiness a 3.71 mean score on a 7-point: higher than any other news


Unfortunately, this is the first year where TV news edged out newspapers as the most prominent news medium that people rely on for news about local communities. TV came in at 33 percent, and newspapers were one percentage point behind at 32 percent. But that's only if you factor in cable, national outlets and TV websites. Without the added factors,

newspapers without their websites were at 30 percent and TV news was at 29 percent. Sixty-four percent of survey respondents said they read a community newspaper either in print or online, showing a small decline from last year. Other sources of news did not fare so well: 8 percent radio and satellite radio. 14 percent internet. 4 percent social media. When respondents were asked if they read a newspaper that is specific to their community, 64 percent said yes. Of those who answered yes, 74 percent said they look forward to reading their community newspaper, and 71 percent said they rely on it for local news and information.

Measure would transfer work camp to county

A Southern Illinois state County for \$1. senator said Sept. 21 that he had filed legislation to begin the process of transferring property ownership of the Hardin County Work Camp to Hardin County.

'The Hardin County Work Camp closure was a devastating setback in the region, eliminating critical jobs in the area and contributing to the economic drain in the region," State Sen. Dale Fowler, R-Harrisburg, said in a news release.

"This legislation is the first step in repairing the damage done by the closure of this facility and bringing economic opportunity to Hardin County and the surrounding areas."

Senate Bill 3634 would allow the Illinois Department of Corrections to sell the Hardin County Work Camp property to Hardin

In turn, Hardin County can use the property for public purposes, including the creation of a detention center.

'The aim of this legislation is to empower Hardin County, placing the property in their control as local officials continue to seek out the funding needed to reopen the facility," Fowler said.

The Hardin County Sheriff's Department recently announced its intentions to reopen the work camp, with the prospect of housing 100 inmates and creating upwards of 40 new jobs in the area.

Fowler is hopeful that Senate Bill 3634 will see movement when the Illinois General Assembly reconvenes for a veto session which is scheduled in November.





Politics: 'one of most interesting subjects for conversation

Editor's note: this ara book titled "History of Union County." The book was written by Lulu Leonard in 1941.

Politics has been one of the most interesting subjects for conversation since our country began.

Political parties developed as controversial matters arose in the country.

At the time of the first elections in Union County, the candidates were not elected because they adhered to opposing party principles due to the fact they were all Jeffersonians: or Republicans.

The choice was made on the basis of personal likes and dislikes because population was not large and most of the settlers had heard of each other since nearly all of them had travelled over the same roads to arrive at their destination.

Note: The writer is indebted to Mr. A. Ney. Sessions for the record of the 1822 poll books which will be used as typical of the whole period to 1850.

The poll books of 1822 show that the names of the candidates were written across the top of the page and the names of the voters down the left side of the page and opposite his name and under the name of the candidates was written the voter's choice.

The County Board of Commissioners appointed election judges and clerks for the elections of the year and it was the duty of the clerk to compile the poll books and the judges to see that he did his work properly.

ticle features excerpts from candidates were written across the tops of the pages, the voters were heard as they arrived at the polls.

> The voter told the judge of the election what candidate he wished to vote for and the clerk placed a mark opposite the voters names under the names of the candidate.

> Each voter's name was placed on a new line and a record of his vote was opposite his name.

> In 1822 the candidates and the number of votes cast for each Governor of Illinois were Thomas C. Brown 96, James B. Moore 9, Joseph Phillips 71, and Edward Coles 75; for Lieutenant Governor, John G. Lofton 22, A. F. Hubbard 65, James A. Peacock 26, and James Lemons 33; for Congress, John McLean 101, and Daniel P. Cook 157; for Senator, John Whitaker 81, John Grammer 162, R. E. Heacock 3, and Henry L. Wibb 0; for Representative, John Mcintosh 138, Alex P. Field 136, James P. Edwards 70, William Echols 107, and John Hunsaker 31; for Sheriff were George Hunsaker 220, and James S. Smith 13; for Coroner, Charles Daugherty 60, Jonathan Lyerle 88, Wesley G. Nimmo 63; for City Commissioner, Cliff Hazelwood 111, Samuel Hunsaker 135, George Brown 160, Samuel Butcher 97, Jessie Echols 100, and for delegate to the national convention, William Barton 58.

After the names of the names of the two leading candidates for each office.

> All of the freeholders, that is, people owning land were allowed to vote at that time. There were 235 voters in the 1822 election.

> In 1850 all free men were allowed to vote but colored men were not allowed to vote until after the Civil

This system of voting was used until 1850. It was easy to see that a man kept his promise to vote for a certain candidate in those days.

An amusing incident is related about a voter in Johnson County who wished to vote for Lincoln, which shows how the judges and clerks helped elect their own candidate. It is possible that no such corrupt practice ever existed in Union County.

It seems that it was generally known that a certain voter was a supporter of Abraham Lincoln and the judges and clerks of the election were opposed to Lincoln.

When the voter came to the polls to cast his vote the judges and clerks ignored him and he was forced to go away without being heard. However he met an influential man in the neighborhood who returned to the polls with him and insisted that his vote must be recorded.

As the population grew and the number of offices and candidates increased this system of voting became too slow to be useful and the system was changed to a ballot system.

Revisiting Method of

February 12, 1849, the Illinois Legislature passed a to be used by

voting in Illinois, establishing the use of ballots and ballot boxes.

The law stated that a general election should be held on Tuesday next after the first Monday in the November preceding the expiration of the term of office of each president of the United States.

The general election for governor, lieutenant governor, secretary of state, auditor of public accounts, state treasurer, representatives to Congress, Senators and representatives to the general assembly and county officers, was to be held biennially, Tuesday next after the first Monday in Novem-

ber, except for such offices as were directed to be chosen other than biennially, namely the governor and other officers who served for terms of four years each instead of two years.

The privilege of voting was given to all white men above the age of 21 who had resided in the state for one year.

The method of voting was changed to a ballot system. Blank ballots with no writing or identifying marks were

law revising the method of voters who wrote the names of the candidates of their choice, folded the ballots and gave it to one of the election judges who placed it in the ballot box without unfolding it.

After the voting was completed, the clerk counted the number of names of voters on the poll book who had voted and the judges counted the number of ballots in the box.

If more ballots were in the box than there were names of voters, a public drawing was held where the judges drew out the number of surplus ballots and destroyed them.


In counting the votes, if two ballots were found

folded together, both were destroyed because this appeared as evidence that someone was attempting to cast more than one vote.

The clerks and judges were allowed to adjourn until the next day after the votes were cast to count the votes. They were required to hand the results of their count to the county clerk within four days after the election and the county clerk was required to publish the returns.


The ballots were returned to the ballot box which was then locked and one election judge kept the key and another the box until the next election if there was no contest.



Executive orders abolish state boards, eliminates nepotism

issued Sept. 21 by Gov. Bruce Rauner to abolish 53 boards and commissions that he said serve no public purpose and have been inactive for years, some for as long as two full decades.

"This is a matter of good government through transparency," Rauner said in a news release.

"The people of Illinois need to understand the ongoing work of the state. They should not be led to believe that people are still at work doing tasks that were completed 10 years ago, or that they are supporting advisory roles for which the need expired in the 1990s."

Over the years, the State of Illinois has created more than 600 authorities, boards, bureaus, commissions, committees, councils, task forces and other similar entities.

Many of them have completed their work and no longer operate, yet they still appear in state publications, public-facing websites and Legislative Research Unit reports as if they were still doing the people's work.

The executive orders issued on Sept. 21 follow another order which the governor issued earlier this year to abolish 19 other moribund entities.

Collectively, the orders eliminate 72 redundant or inactive boards and commissions so that executive branch operations are more transparent and efficient, the governor said.

One of the organizations that Rauner eliminated Sept. 21, the State Government Accountability Council, was formed in 1999 and there isn't any recorded activity since that



The late Mrs. Wiggs prepared and bequeathed numerous historical photographs and documents that folks appreciate today.

World issues and their impact here at home

A front page headline in last Monday's New York Times reads "China, Facing U.S. Hostility, Vows to Come Out Swinging." Of course, most of our readers do not directly import goods from China, but this relationship, which could evolve into a major trade war affects each of us.

It is easy to overlook the extent to which we are economically interconnected. I suspect that most of you can look within your own home and find furniture or other items produced in another country. For me that applies to looking in my refrigerator.

The latest proposal by our president would place a \$200 billion tax on imports from China. The Chinese response could take one of two paths, or a combination of both.

The first would be to simply pass along this extra cost to U.S. consumers, which would immediately increase the cost of your next computer, TV or other electrical devices that depend on Chinese imports.

The second path would be to place an equivalent tax on items imported into China. This would risk a significant drop of sales by U.S. firms and ultimately result in a drop in U.S. employment opportunities.

Some will argue that if we tax the imports, we would simply shift to purchasing products of U.S. manufacture. While there would be some of this, history does show the likelihood of a net gain for U.S. consumers.

Since it is far easier in the world of internet for ordinary citizens to follow and assess trade issues, I would encourage more people to do so and to advise your elected officials how you would have them vote. It does make a difference.

This week, we're just going to bug you. With big bugs. And a VW bug, too.


As you have probably figured out, I like to take pictures of bugs. And turtles. And birds. And deer. And bunnies. And the occasional person, too.
