We hope everyone has a safe and enjoyable Labor Day weekend.

As we have noted many times over the year...if you plan to celebrate during the weekend, please do not drink and drive.

The weather forecast early this week suggested that the Labor Day weekend could be very nice.

The National Weather Service office in Paducah says that "below normal temperatures are favored across our region" during September. The outlook for the month also calls for "wetter than normal condi-

tions."

Southern Seven Health Department is working to raise awareness about substance use, and abuse, during the pandemic.

Union County Democrats shared in an email that they started putting up Biden/Harris signs on Monday and, as of Tuesday, "several have been stolen already. One in broad daylight yesterday. All were taken off private property."

County remains at COVID-19 warning level

The Illinois Department large gatherings, long-term dicators when determining of Public Health, IDPH, on Friday, Aug. 28, reported 30 counties in Illinois are considered to be at a warning level for novel coronavirus disease (COVID-19).

Union County continued to be at a warning level based on statistics from the period of Aug. 16 through Aug. 22.

IDPH said that a county enters a warning level when two or more COVID-19 risk indicators that measure the amount of COVID-19 increase.

As of Friday, the 30 counties which were reported to be at a warning level included:

Union, Bureau, Carroll, Cass, Clinton, Cook, Cumberland, Effingham, Fayette, Greene, Grundy, Henderson, Henry, Jasper, Jersey, Jo Daviess, Johnson, Madison, Monroe, Morgan, Perry, Pike, Randolph, Sangamon, Shelby, St. Clair, Warren, White, Will and Williamson.

Although the reasons for counties reaching a warning level varies, IDPH said that some of the common factors for an increase in cases and outbreaks are associated with weddings,

care facilities and other congregate settings, travel to neighboring states, bars and spread among members of the same household who are not isolating at home. Cases connected to schools are beginning to be reported.

General transmission of the virus in the community also was increasing.

Public health officials said they are observing people not social distancing, gathering in large groups and not using face cover-

IDPH stated in a news release that in some counties, local law enforcement and states' attorneys are not enforcing important mitigation measures like social distancing and the wearing of face coverings.

Several counties are taking swift action and implementing mitigation measures to help slow spread of the virus, including increasing testing opportunities, working with schools, meeting with local leaders, and educating businesses and large venues about the importance of mitigation measures.

IDPH uses numerous in-

if a county is experiencing stable COVID-19 activity, or if there are warning signs of increased COVID-19 risk in the county.

A county is considered at the warning level when at least two of the following metrics triggers a warning.

New cases per 100,000 **people.** If there are more than 50 new cases per 100,000 people in the county, this triggers a warning. Union County had a rate of 190 per 100,000

Number of deaths. This metric indicates a warning when the weekly number of deaths increases more than 20 percent for two consecutive weeks. Union County had no deaths for the period.

Weekly test positivity. This metric indicates a warning when the sevenday test positivity rate rises above 8 percent. Union County had a rate of 8.2 percent.

Tests performed. This metric is used to provide context and indicate if more testing is needed in the county. Union County's number for the period was

An increase in confirmed COVID-19 cases in the southern seven counties in Illinois has prompted Southern Seven Health Department to schedule two mobile testing units in the region.

The Illinois Department of Public Health, IDPH, plans to set up a COV-ID-19 mobile testing unit at Southern Seven Health Department's clinic office in Anna on Sept. 5. The office is located at 260 Lick Creek Rd.

A mobile testing unit also is scheduled to be set up on Sept. 6 at Southern Seven Health Department's clinic office in Vienna. The office is located at 513 1/2

Both testing sites are scheduled to be open to the public from 9 a.m. to 5 p.m. for drive-thru service.

Southern Seven Health Department advised that anyone who is in need of a COVID-19 test, even those without symptoms, can be tested without an appointment or doctor's referral.

The test is free, regardless of insurance. Those with insurance are asked to bring their insurance card.

The health department said that residents who are not able to be tested on either day are asked to watch for these symptoms:

Fever or chills, cough, shortness of breath, fatigue, body aches, headache, new

loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting and diarrhea.

"If symptoms develop, begin isolation immediately and contact your healthcare provider about getting tested for COVID-19, Southern Seven Health Department stated in a news release.

On Aug. 26, Southern Seven reported a cumulative total of 769 COVID-19 cases and 23 deaths in the southern seven region since the start of the pandemic in the United States.

Southern Seven Health Department said that it "continues to see community transmission of COVID-19 at social events and gatherings at alarming rates."

There is no cure or vaccine to prevent COVID-19. Southern Seven wants anyone who thinks they may be at risk for contracting this disease to be tested.

"It is through testing and contact tracing that we can slow the spread of this disease to our most vulnerable populations," the health department stated.

County has 415 COVID-19 cases

Union County has more than 400 COVID-19 cases. The number of COVID-19 cases in the county climbed to 415 as of Monday, Aug.

Southern Seven Health Department on Monday confirmed a total of 26 new cases of COVID-19 in the region it serves in Southern Illinois.

Eight of the new cases were in Union County.

The health department reported that the newly confirmed cases, by county, gender and age, included:

Union County: one male under 5, one male under 10, two females in their 40s, two males in their 50s, one female in her 60s and one

male in his 60s. Johnson County: two females in their 20s, two females in their 40s, one female in her 30s, one male in his 30s, two males in their 50s.

Massac County: one female in her 70s.

Pope County: one female in her 10s, one female in her 50s, one male in his 50s, two males in their 60s.

As of Aug. 31, there were 629 people in the health department's service area who had recovered since the start of the pandemic in the United States.

Also as of Aug. 31, the health department was reporting a cumulative total of 803 cases of COVID-19 in its service area. There were 148 active cases in the region.

The health department confirmed that a total of 12,052 negative COVID-19 tests had been reported in the region as of Aug. 28.

Twenty-three deaths had been reported in the region since the start of the pandemeic.

According to the Illinois Department of Public Health, in Illinois there were 1,668 new individuals with COVID-19 identified on Aug. 31, bringing the confirmed total in the state to 235,023 individuals, with 8,026 deaths.

The remnants of Hurricane Laura brought heavy rain to the region, including the Union County area, last

The region experienced more heavy rain on Monday.

The National Weather Service office in Paducah was calling for continuing chances of locally heavy rainfall on Tuesday, Wednesday and Thursday of this week.

At about 3:30 p.m. Monday, Aug. 31, the weather service issued an urban and small stream flood advisory for southern Union County, Alexander County, Pulaski County and parts of Southeast Missouri.

At the time that the advi-

sory was issued, the weather service reported that Doppler radar "indicated heavy rain due to thunderstorms. This will cause urban and small stream flooding. Between 1 and 2 inches of rain have fallen."


More rain appeared to be on the way as the paper went to press on Tuesday.

The weather service reported on Tuesday that 'the potential exists for one or more periods of heavy rainfall this week.

"Rainfall rates in thunderstorms could exceed 1 inch in 30 minutes. The rates may be more important than the totals.

"Soil conditions may become saturated, leading to an increased flood threat."

Weekly emergency department visits. This metric indicates a warning when the weekly percent of COVID-19-like-illness emergency department visits increase by more than 20 percent for two consecutive weeks. Union County reported 5.5 percent.

Weekly hospital admissions. A warning is triggered when the weekly number of hospital admissions for COVID-19-likeillness increases by more than 20 percent for two consecutive weeks. Union County had fewer than five.

Clusters. This metric looks at the percent of CO-VID-19 cases associated with clusters or outbreaks and is used to understand large increase in cases.

Union County had a number of 2.8 percent.

ICU availability. If there are fewer than 20 percent of intensive care units available in the region, this triggers a warning. Union County had a number of 56.0 percent.

IDPH said the metrics are intended to be used for local level awareness to help local leaders, businesses, local health departments, and the public make informed decisions about personal and family gatherings, as well as what activities they choose to do.

The metrics are updated weekly, from the Sunday-Saturday of the prior week.

Saturation Saturday held

The Illinois Department of Transportation, IDOT, shares a common goal with Mothers Against Drunk Driving, MADD, and Illinois law enforcement agencies: the elimination of impaired driving.

As the unofficial end of summer approaches, MADD, IDOT, the Illinois State Police and law enforcement agencies throughout the state teamed up for "Saturation Saturday" on Aug. 29 to remind motorists that driving under the influence of drugs or alcohol is a dangerous crime.

During the annual event, the Illinois State Police, local police and sheriff's departments step up enforcement to keep impaired drivers off Illinois roads.

The goal is to save lives by reminding motorists that driving under the influence is a serious crime with sobering consequences.

IDPH issues safety guidelines for election

2020 elections, the Illinois Department of Public Health, IDPH, has issued guidance to protect the safety and health of voters as they cast ballots at polling locations throughout the state during early voting and Election Day, which is set for Tuesday, Nov. 3.

"Voting is a right and a privilege," IDPH director Dr. Ngozi Ezike said in a news release.

"While the safest way to cast a ballot this year is voting by mail, we are and will continue to take the necessary steps to ensure that Illinoisans can exercise their right to vote in person, in the safest possible environments during this COVID-19 pandemic."

In accordance with the guidance, all local election to develop written CO-VID-19 prevention plans for all polling sites within their jurisdiction.

Plans will contain specific COVID-19 safety and training instructions along with the names of individuals responsible for implementation of the plan.

Election authorities are being strongly encouraged to relocate polls previously housed in long-term care facilities and senior living residences to protect voters and residents – particularly those who are most vulner-

All locations will have signage to encourage voters to wear masks and maintain a distance of 6 feet, while inside the polling places.

Animal control concerns discussed at Friday's county board meeting

Concerns about an animal control matter were addressed at last week's regular meeting of the Union County Board of Commissioners.

The meeting was Friday morning, Aug. 28, at the Union County Courthouse in Jonesboro. The meeting also was livestreamed on YouTube.

The animal control matter involved vicious dogs in Jonesboro. Residents who spoke at the meeting said the situation has been going on for many years.

Several Jonesboro residents were on hand to address their concerns with county officials about what were described as aggressive dogs. Union County operates a county-wide animal control program.

After hearing from the residents, county board chairman Max Miller said he appreciated the concerns which they raised.

Miller assured those who attended the meeting that the matter would be pursued. "We will take everything you said to heart, he said.

"This is obviously a problem that needs to be fixed," Union County State's Attorney Daniel Klingemann said.

In other business at Friday's meeting:

Plans were announced to start interviews with five finalists for the post of Union County highway engineer.

Long-time county highway engineer Kevin Grammer is planning to leave the post in December.

The board approved four policies related to audit recommendations.

The policies cover fixed assets, purchasing, cost allocation and basis of accounting. The county already had been implementing policies related to the recommendations.

County administrator Angie Johnson noted that in response to one of the policies, a physical inventory of the county's assets will be done.

County board chairman Miller voiced appreciation to all of the officials who had worked on drafting the policies.

The board approved a county tourism grant allocation in the amount of \$4,000 to the Shawnee Hills Wine Trail Lodging Association.

County board vice chairman Bobby Toler Jr. reported that an area healthcare constorium is being formed. The consortium will involve such entities as the Shawnee Development Council, Shawnee Community College and others.

Southern Illinois health centers receive federal grant funds to help fight COVID-19

of Health and Human Services has awarded a series of grants totaling over \$960,000 to health centers across Southern Illinois through the Health Center Cluster funding program.

The discretionary funds will be used to combat the spread of COVID-19.

U.S. Rep. Mike Bost, R-Ill., announced the funding on Aug. 27.

Southern Illinois health centers which are receiving grants include:

Rural Health Inc. in Anna, \$175,250.

Shawnee Health Service and Development Corporation in Carterville, \$296,184.

Community Health & Emergency Services Inc. in Cairo, \$196,474.

Christopher Greater Area Rural Health Planning Corporation in Christopher, \$85,750.

SIHF Healthcare in East St Louis: \$209,100.

"Southern Illinois, like the rest of the country, has been hit hard by CO-

The U.S. Department VID-19, yet many of our rural hospitals and health centers don't have access to the same level of resources as those in large metropolitan areas," Bost said in a news release.

"These grants will provide Southern Illinois health centers with critical resources to continue fighting COVID-19 and keep communities safe and healthy."

Sheriff issues monthly report

Union County Sheriff Scott Harvel has released his department's monthly activity report for July.

Highlights from the report follows:

Felony arrests, eight. Misdemeanor arrests, three. Traffic arrests, 28. Warrant arrests, one. Total arrests,

Cases opened, 36. Drug investigations, three. Crash reports, 13.911 calls, 2,034. Miles patrolled, 11,462.

In preparation for the authorities will be required election authorities are required to offer them a face covering outside of the polling place.

Polling booths will be set up at least 6 feet apart and foot traffic will be onedirectional.

Additional recommended preventative actions in the guidance include:

Using plexiglass barriers between election officials and voters, large print instructions to facilitate communication, routine cleaning of frequently touched surfaces, and polling place personnel to remind voters to maintain physical distance.

While election officials are prohibited from preventing a voter without a face covering from casting a ballot, the guidance requires they take every reasonable action to separate noncompliant voters, ensuring they are socially distanced from those voters who are compliant.

Union County Plans

Union County Clerk Lance Meisenheimer recently announced initial plans for the 2020 general election.

"One new thing is that we will be having the early voting in the community room in the courthouse," Meisenheimer said.

The Union County Courthouse is in Jonesboro. The county clerk's office and the community room are

the courthouse.

"I decided to move it there to separate the office staff from the election judges and voters so that if by chance there is a CO-VID-19 exposure in either room, we can then adjust and not have everyone exposed," the county clerk stated.

Union County Board of Commissioners meetings take place in the meeting room. Regular meetings are scheduled at 8:30 a.m. on the second and fourth Friday of each month.

"The board meetings will still continue and voting will be going on in my office while the board meeting is going on but for the most part, we will have the voting in the community room. I did contact the State Board of Elections and they approved this to be handled this way," Meisenheimer

The county clerk said that he has purchased 150 masks for each of the county's precincts.

He also noted that Anheuser-Busch is donating hand sanitizer to every precinct in the whole state of Illinois.

"I cannot require everyone to wear a mask and hopefully most people will have a mask but we are highly encouraging everyone to wear a mask at the polls," Meisenheimer



Census response rates lag in area counties

Department continues to promote the area's participation in the 2020 nationwide

As of Aug. 31, area counties served by Southern Seven Health Department were behind in their response to the 2020 census, when compared to 2010.

The health department serves seven area counties, including Union County.

Overall, the seven counties had a census response rate of 52.9 percent, as of Monday. That was down from the 2010 response rate of 59.7 percent.

As of Monday, Union County had the highest response rate among the seven counties at 66.7 percent. That was down from the 2010

response rate of 68.8 percent. Southern Seven Health

IDNR reminds waterfowl hunters about dates for 2020-2012 seasons

The Illinois Department of Natural Resources, IDNR, is reminding waterfowl hunters of key dates and other information regarding the 2020-2021 waterfowl seasons and beyond.

Public Duck, Goose **Hunting Permits**

The application periods for Illinois public duck and goose hunting area permits are open.

A deadline of Aug. 31 was set to apply for the first

The second application period started Sept. 1 and continues through Sept. 14. The third lottery is set Sept. 15-28.

Permits remaining after the third lottery will be available on a first-come, first-served basis online starting Oct. 1.

Permits are no longer mailed to successful participants but will be emailed, and participants can check the status of their permit

IDNR advised that hunters should note several changes to the duck and goose hunting area permits.

In anticipation of required changes at duck and goose hunting area permit sites due to the coronavirus pandemic, permit allotments have been increased at several sites.

IDNR anticipates not being able to hold daily standby drawings at sites for unallocated permits or no-show permit holders.

Permit allotments have been increased to equal the total number of hunting stakes/blinds at these sites.

Local hunters accustomed to hunting these sites via standby drawings should apply for permits to ensure they can hunt these

sites this season. More information, including online applications, instructions and a list of participating sites is available on the IDNR website at https://www2.illinois. gov/dnr/hunting/waterfowl/ Pages/OnlinePermitAppli-

cation.aspx. Among the permit sites with anticipated changes to standby hunting are the Union County SFWA, Horseshoe Lake SFWA in Alexander County and Mermet Lake SFWA.

Additional Changes

Changes to daily procedures at other waterfowl hunting sites are anticipated in response to the ongoing coronavirus pandemic.

IDNR advised hunters to watch for additional press releases outlining changes and to check with sites for specific procedures.

IDNR said that through season in each zone. responsible actions, hunters can help to ensure that it can continue to offer outdoor recreation opportunities.

2020-2021 Waterfowl Seasons

Illinois waterfowl hunters are reminded of the season dates and bag limits for the 2020-2021 seasons.

The September 2020 early Canada goose season was scheduled to begin Sept. 1 and continues through Sept. 15.

There is a daily limit of two and a possession limit of six geese in the South Central and South zones.

Illinois' 16-day 2020 statewide teal hunting season is scheduled Sept. 5-20, with a daily limit of six and a possession limit of 18.

Shooting hours for the September teal season are different from the regular season, starting at sunrise (one-half hour later than regular season) until sunset.

The regular seasons inapplication online and print clude 60-day duck seasons in each of the state's four waterfowl hunting zones, along with 107 days of Canada goose hunting opportunity in the North and Central zones (15 days in September, two days of youth hunting and 90 days of "regular" goose season), 96 days of Canada goose hunting opportunity in the South Central Zone, and 84 days of Canada goose hunting opportunity in the South Zone.

Goose season lengths are shorter in the South Central and South zones to coincide with duck season dates and to match hunter preferences.

The 2020-2021 Illinois season dates are the last year of a five-year plan that was developed in 2015.

This year, Illinois will open the regular duck, Canada goose, and snow goose seasons on Oct. 17 in the North Zone, Oct. 24 in the Central Zone, Nov. 14 in the South Central Zone and Nov. 26 in the South Zone.

White-fronted goose (specklebelly) seasons will open Oct. 19 in the North Zone, Nov. 5 in the Central Zone and on the same date as duck season in the South Central (Nov. 14) and South zones (Nov. 26).

The daily duck bag limit is six and may include no more than four mallards (two hens), three wood ducks, two redheads, two black ducks, two canvasbacks, one pintail and one mottled duck.

Scaup (bluebills) will have a bag limit of two for the first 45 days of the season in each zone and one for the last 15 days of the

The daily bag limit of mergansers is five, only two of which may be hooded mergansers.

The possession limit for ducks and mergansers is three times the daily bag limit by species and sex. During the regular sea-

son, Canada goose limits will be three, with a possession limit of nine. White-fronted goose dai-

ly bag limits will be two, with a possession limit of The snow goose daily bag limit is 20 birds, with





Illinois organ/tissue donor registry reaches 7 million registrants

The State of Illinois' organ/tissue donor registry has reached a milestone of 7 million registrants.

"I am so proud that Illinoisans continue to show their giving spirit and commitment to others by signing up for this lifesaving program," Illinois Secretary of State Jesse White said when he announced the achievement.

"Our mission is to strengthen the Organ/Tissue Donor Program through outreach and registration initiatives. We want to end the waiting for the approximately 4,000 people statewide. Each year about 300 people die waiting for a transplant in Illinois," White said in a news re-

There are 10,764,540 individuals in Illinois who people."

qualify to become organ/ tissue donors.

Of those, 65 percent have registered as organ/tissue donors. There are more than 12.6 million people living in Illinois, according to the U.S. Census Bureau in 2019.

In addition, more than 100,000 16- and 17-yearolds have registered with the program since 2018 when White initiated a law allowing them to register as organ and tissue donors.

"I believe our public awareness campaign, including television, radio and social media ads have helped encourage people to register," White said.

"It takes less than a minute to register and one

White heads the state's Organ/Tissue Donor Registry.

The life-saving program has been one of White's top priorities during his 21-year administration.


He has visited countless hospitals, schools, libraries, driver service facilities as well as other venues to promote and register Illinoisans for the donor program.

State public health officials highlight importance of testing

Following the Centers eas in the northern, central confirmed case be tested for for Disease Control and Prevention's, CDC, recent announcement on changes regarding COVID-19 testing protocols, the Illinois Department of Public Health, IDPH, is reminding all Illinois residents of the importance of getting tested, including after close contact with someone who has tested positive.

The Pritzker administration's strategy to combat COVID-19 across Illinois has always relied on increased testing.

IDPH state labs were the first labs outside of the CDC to test successfully for COVID-19 early in the

state's pandemic response. Since March, Illinois had, as of Aug. 27, tested more than 3.8 million COVID-19 specimens and

and southern parts of the state.

"In the face of increasing infections, we need to promote more testing, not less, to identify new cases and interrupt further transmission," said Illinois Department of Public Health director Dr. Ngozi Ezike.

"Given that asymptomatic individuals have been stringent guidance to support testing of any Illinois resident who thinks they may have been exposed, as well as asymptomatic close contacts of confirmed cases five to seven days post exposure."

The recent change in federal guidelines on COVID-19 testing does not recommend asymptomatic individuals who come the deadly virus.

Many individuals who test positive for COVID-19 have not reported having symptoms.

However, scientific studies have proven that those individuals are still able to spread the disease to family, friends, and members of their community who may become linked to virus spread, we sick and require medical will maintain our more attention and even hospitalization, especially for those with underlying health conditions.

Illinois will continue advising anyone who comes into close contact with a confirmed case be

There are almost 300 testing sites in Illinois, including 11 state operated community-based testing sites and 12 mobile testing teams that collect specimens at facilities experiencing outbreaks (such as nursing homes and correctional centers) and areas around the state reporting increased cases.

Additionally, IDPH is deploying its Wellness on Wheels mobile unit to hot spots around the state to work with local health providers to collect specimens.

Testing at state-operated sites is at no cost to the individual, as are several other sites.

Labor Day honors American workers The following article appears on the U.S. Department

of Labor website: Labor Day: What it

Labor Day, the first Monday in September, is a creation of the labor movement and is dedicated to the social and economic achievements of American workers.

It constitutes a yearly national tribute to the contributions workers have made to the strength, prosperity, and well-being of our country.

Labor Day Legislation

The first governmental recognition came through municipal ordinances passed in 1885 and 1886.

From these, a movement developed to secure state legislation.

The first state bill was introduced into the New York legislature, but the first to become law was passed by Oregon on February 21,

During 1887, four more states-Colorado, Massachusetts, New Jersey, and New York - created the Labor Day holiday by legislative

By the end of the decade Connecticut, Nebraska and Pennsylvania had followed

By 1894, 23 more states had adopted the holiday, and on June 28, 1894, Congress passed an act making the first Monday in September of each year a legal holiday in the District of Columbia and the territories.

Founder of Labor Day

There is still some doubt as to who first proposed the holiday for workers.

Some records show that Peter J. McGuire, general secretary of the Brotherhood of Carpenters and Joiners and a cofounder of the American Federation of Labor, was first in suggesting a day to honor those "who from rude nature have delved and carved all the grandeur we behold.'

But Peter McGuire's place in Labor Day history has not gone unchallenged.

Many believe that Matthew Maguire, a machinist, not Peter McGuire, founded the holiday.

Recent research seems to support the contention that Matthew Maguire, later the secretary of Local 344 of the International Association of Machinists in Paterson, N.J., proposed the holiday in 1882 while serving as secretary of the Central Labor Union in New York.

What is clear is that the Central Labor Union adopted a Labor Day proposal and appointed a committee to plan a demonstration and picnic.

The First Labor Day

The first Labor Day holiday was celebrated on Tuesday, September 5, 1882, in New York City, in accordance with the plans of the Central Labor Union.

The Central Labor Union held its second Labor Day holiday just a year later, on September 5, 1883.

By 1894, 23 more states had adopted the holiday, and on June 28, 1894, President Grover Cleveland signed a law making the first Monday in September of each year a national holiday.

A Nationwide Holiday

The form that the observance and celebration of Labor Day should take was outlined in the first proposal of the holiday: a street parade to exhibit to the public "the strength and esprit de corps of the trade and labor organizations" of the community, followed by a festival for the recreation and amusement

families. This became the pattern for the celebrations of Labor Day.

of the workers and their

Still later, by a resolution of the American Federation of Labor convention of 1909. the Sunday preceding Labor Day was adopted as Labor Sunday and dedicated to the spiritual and educational aspects of the labor movement.

The character of the Labor Day celebration has changed in recent years, especially in large industrial centers where mass displays and huge parades have proved a problem.



But if you are experiencing pressure or pain when bending, lifting, or coughing, you may have a hernia that won't go away without medical attention. A hernia is a condition

characterized by a protrusion of an organ into an opening. More common in men

over age 40, hernias typically occur in the abdomen as a result of muscle weakness and strain. Some may have a hernia

in the belly button, groin, abdominal wall and upper thigh region.

Hernias also can be due to congenital disabilities, injuries, straining activities such as lifting heavy weights, chronic coughing, and even pregnancy.

The most common symptom of a hernia is a bulge or lump on your pubic bone.

Some may notice a lump near the belly button, old surgical scar, abdomen, groin, or upper thigh region. In some cases, patients with hernias do not experience any symptoms.

Some types of hernias, however, can cause symptoms like pain, discomfort, swelling, tenderness, pain on walking or performing tasks.

"About five percent of the population will develop abdominal wall hernia,' said Dr. Tamer Aiti, general surgeon at Union County Hospital in Anna.

"About seventy-five percent of these individuals will have an inguinal hernia, a protrusion of the abdominal

"Inguinal hernias turn severe when the intestines protrude into the scrotum, obstructing blood flow.

"Untreated hernias are extremely painful for patients and can become gangrenous,

which is fatal."

The only option to fix a hernia is surgery. For adults, maintaining a healthy weight, regular exercise and avoiding heavy lifting can help prevent an inguinal hernia.

Fear of the coronavirus shouldn't keep you from scheduling an appointment for pain.

Obituaries

Joseph M. Glisson

Joseph M. Glisson was born on Jan. 6, 1948, and, with his devoted wife by his side, Joe passed away quietly on Sunday, Aug. 2, 2020, at the Margret Dozier House of Big Bend Hospice.



An Alabama native, Joe was born in Montgomery and grew up in Tuscaloosa. As a kid, Joe fell in love with the woods and always found great solace in nature especially after losing his maternal grandfather and mentor at 14.

After high school, Joe briefly attended college, joined the Air Force before an injury cut his service short, and worked several jobs.

On a whim, Joe applied to be a police officer for the City of Tuscaloosa. He was hired, and it changed his life. While serving, Joe returned to college and earned a bachelor of social work degree from University of Alabama, where he served as president of the social work student organization and worked for social reform within the university.

He then received a master's degree with a double major (criminal justice and education) from Wichita State University followed by teaching at Southeast Missouri State University, SEMO, where Joe created the criminal justice degree program and began his doctoral studies at Southern Illinois University.

His SEMO students gave him a plaque to express their gratitude for his mentorship.

His doctoral studies continued first on campus, then while teaching at Illinois State University, then while working in the governor's office in Hawaii.

He returned to SIU to finish his Ph.D. in higher education and remarried after meeting the love of his life,

He then bought the 100-year old Pomona General Store, next to the national forest. There he led a small group of citizens to form the Regional Association of Concerned Environmentalists (RACE) to stop the Cave Valley Timber Sale on the national forest in an ecological sensitive avian area near the store. RACE stopped the timber sale and saved Cave Valley.

They went on to have a significant impact on management of the Shawnee National Forest.

Joe was able to sue the government as a private citizen on behalf of the environment. He litigated before the U.S. District Court for the Southern District of Illinois and U.S. Court of Appeals for the Seventh Circuit in Chicago.

A retired U.S. District Judge credited Joe with teaching him about the environment. District federal clerks told him that he wrote better legal briefs than most lawyers.

After Joe sold the store, he and Jackie found themselves living next to a threatened stream.

Joe sued a local city to stop their attempts to dam a nearby state-designated biologically significant stream that was home to a threatened fish and an endangered crawfish. Joe's case went all the way to the Illinois Supreme Court. Although he did not prevail, the stream still flows today.

After many years in Southern Illinois, Joe and Jackie moved to Florida. Joe became aware of the threat to Wakulla Springs from the City of Tallahassee's spray

He sued the City of Tallahassee to hold them to account for their impact on Wakulla Springs and the Florida Department of Environmental Protection for permitting the city to allow the impact to continue.

The Florida Wildlife Federation, Wakulla County and the Florida attorney general joined Joe's lawsuit that

resulted in an agreement that the city immediately broke. However, they did implement major facility upgrades to reduce their nitrogen output, which in turn reduced the

nitrogen level at the spring. Like most folks, Joe became an environmentalist because a place he loved was threatened. Once he found his legal niche, Joe dedicated his life to holding governments to account for their responsibility to protect the natural

He was a good man and a loyal friend. Those who loved him feel incredibly fortunate to have known him.

He was a devoted husband, who supported his wife's professional development. He and Jackie deeply loved one another and had an incredible life together.

He was a highly intelligent man, who used his talents

and abilities to help others and defend the natural world. He intended to write his book "From Street Cop to Tree Hugger." Unfortunately, he did not take the time to write about himself.

Joe is survived by his wife, Jackie Turner; his son Joseph Aldridge; grandchildren Samantha and Will Aldridge; his brother, Charles Glisson (Joyce Feld) and nephew and niece, Matt and Erin Glisson.

Joe was cremated by Bevis Funeral Home in Crawfordville, Fla. There will be no funeral service.

A Celebration of Life will be held at a later date, both in Florida at Wakulla Springs State Park and in Southern Illinois on the Shawnee National Forest. Memorials can be made to Big Bend Hospice or to Shriners Hospitals for Children.







Can a Republican ever win election again as governor of Illinois?

The recent passing of Illinois Republican Gov. Jim Thompson (who served from 1977 to 1990) begs the question: Can the Illinois Republican Party ever again capture the governor's office?

The only answer I can come up with is, unfortunately: Not likely, but not impossible. Here's why.

Jim Thompson served four terms, twice as many as any governor in Illinois history. He probably could have been elected to a fifth, though he was running out of money to do things for people.

I was in and out of his administrations, from volunteer policy research in his first campaign, to several troubleshooting agency directorships (never fixed a one of them), to drafting his fourth inaugural address.

Jim liked people, all people – from the little guy to the big shots, from country folk to urban minorities. As with many politicians, he also wanted to be liked, and he was. He was smart, enjoyed negotiating, coming to a deal. His style was collaborative rather than combative. Jim attracted good people to run his agencies, and he let them do the managing.

Jim believed in his Illinois. He wanted to build out our state, from Chicago skyscrapers and sports stadiums to downstate highways. Jim loved selling Illinois. He set up state marketing offices in big cities all over the world, and enjoyed immensely taking delegations across the ponds to try to bring business back to Illinois. And he was successful, as with bringing Mitsubishi Motors to Normal (now Rivian Motors).

Jim was moderate, even liberal. He was pro-choice, pro-union, pro-spending; he added lots of pension benefits for public employees (including doubling his own), yet put off paying for them.

Conservative Republicans grumbled under their breath about Big Jim, but he was tough on crime with his determinate, Class X long sentences, which they applauded.

The Illinois GOP of 2020 would not be comfortable with Big Jim. The Party is opposed to lots of things Jim was for – women's choice, unions, welfare, Chicago, spending and taxes.

The Illinois GOP of the present seems to me most comfortable exhorting voters to return to traditional small-town, conservative values. And that is the problem for Republicans.

The largely small-town downstate that lies outside metro-Chicago has but one-third of the state's votes and only leans Republican. Thus, the GOP cannot win statewide without strong support in the suburbs, and by making at least some inroads into heavily Democratic Cook County and its Chicago.

Cook County accounts for almost two-fifths of the statewide vote, and in 2018 gave Democratic statewide candidates almost 3-to-1 majorities. Even more startling for old-time political observers, the Democratic candidates actually carried the once rock-ribbed GOP suburban "collar counties."

So, it looks bleak for statewide wins for the Illinois GOP, though not impossible. After all, starting with Jim Thompson in 1977, Republicans held the governor's office for 26 straight years.

To win, I think the following must be understood:

Most political party organizations, including that of the Illinois GOP, have atrophied to near helplessness. Candidates must build their own volunteer organizations, and they must also find ways to reach the voters. In statewide races across a state 400 miles deep and with almost 13 million people, that requires big money, the commodity that has replaced parties.

Second, a successful statewide Republican candidate will have to be either moderate on social issues like abortion and guns – or at least come across as a conservative whom voters can relate to, feel comfortable with, such as Ronald Reagan.

In my Central Illinois, I identify three GOP comers who might just put together what is needed for statewide success: State Sen. Jason Barickman of Bloomington, U.S. Rep. Adam Kinzinger of Manteno and State Sen. Sue Rezin of Morris, the latter two on the edge of the suburbs. All are smart, reasonable politicians who know how to work across the partisan aisle. True conservatives might want to get behind attractive U.S. Rep. Darin LaHood of Peoria. There are, I'm sure, other "comers" elsewhere in the state.

Downstate candidates have added challenges. First, they are outside the critical Chicago media lens. For example, Jim Thompson became almost a household word throughout the metro-Chicago area via the nightly news, as a crusading, corruption-busting U.S. attorney.

Second, downstaters are generally not privy to the company of the Chicago-area Daddy Warbucks donors, that is, the tight-knit, near-billionaire community who have

become the primary funders of big political campaigns. The overwhelming Democratic dominance of Illinois that has developed since 2000 is not healthy. A Jim Thompson-type of Republican might have a chance statewide. Other than that, it's going to be real tough.


We just sat and watched them for a while. A couple of other folks drove by.
