### Revolutionary War veterans honored at ceremony

Four patriots who served for money, booty, glory and during the Revolutionary War were honored during a special ceremony which was held on a rainy Saturday afternoon at the St. John's Lutheran Church Cemetery near Dongola.

The cemetery is located west of Dongola, across the road from its namesake church.

At about the time the ceremony was scheduled to begin, a brief downpour fell as a thunderstorm passed over.

The cemetery in Union County is the final resting place for many early pioneers of Illinois settlement, including four Revolutionary War veterans.

St. John's Lutheran Church Cemetery is the final resting place for veterans Adam Clapp, Christopher Lyerle, Jacob Hileman and Peter Meisenheimer.

As part of the Illinois bicentennial celebration during 2018, the Illinois Society Sons of the American Revolution have undertaken a statewide project to mark all active cemeteries that contain Revolutionary War veteran burials. The Revolutionary War was fought from 1775 to 1783.

Last Saturday afternoon, a new plaque which is on display at the cemetery was unveiled during a ceremony sponsored by the Long Knives Chapter of the Illinois Society Sons of the American Revolution.

The Long Knives Chapter has members from the southern 15 counties in Illinois. The 66 members of the chapter all have documented connections to ancestors who served during the American Revolution.

Dick Chamblin of Decatur is the president of the Illinois Society Sons of the American Revolution. Chamblin was one of the speakers at the ceremony.

Chamblin said those who gathered for the ceremony were honoring four soldiers who "defeated the British to establish a nation of free men and women."

"These men served in a citizen army and many were untrained in the accepted art of battle. They faced a highly trained army.

"But the colonial soldier had one superior advantage over the British soldier. The British soldier was fighting

advancement.

"The colonial soldier was fighting for a better way of life for himself and his family...he was fighting to create a nation free from the tyranny of the English king.

'Our patriots were fighting to create a nation that allowed citizens to participate in their government.

'They were successful... and we can never honor them enough. God bless our patriots and God bless America.'

### **GOP** legislators voice concerns about pardon of former governor

to the U.S. House of Representatives has sent a letter to President Donald Trump sharing their concerns over White House talks of pardoning and/or commuting the sentence on former Illinois Gov. Rod Blagojevich.

U.S. Rep. Mike Bost, R-Ill., was among the seven GOP legislators who sent the letter, which was dated

After sending the letter, Bost released a statement on the matter.

"I served on Illinois' House committee to impeach Governor Blagojevich and I believe that he received the sentence he deserved," Bost said.

"He violated the public trust and is an example of the absolute worst about politics. Granting clemency to Rod Blagojevich could set a very bad precedent regarding public corruption."

In the letter, the legislators said they had written "a unified message" to the president regarding his "recent comments contemplat-

The entire Illinois Re- ing the pardon and/or compublican Party delegation mutation" of Blagojevich's sentence.

> The legislators said that the facts of the former governor's case "show a much larger problem and underlying pattern of public corruption" which culminated in what they said was "the ultimate act of public corruption: attempting to sell a United States Senate seat."

"While we understand that, as president, you have the privilege and right under our Constitution to grant pardons and clemency as you determine fit, we ask that you consider very carefully the precedent this may set and the impact it will have on acts of public corruption in the future," the legislators wrote.

"As you well know, the integrity of our democracy and the core of American values depend on our elected officials being honest in upholding the trust given to them by the American people.

"Granting clemency to Rod Blagojevich would go against this trust."

### Man sentenced for aggravated battery of Anna police officer

Union County State's Attorney Tyler R. Edmonds reported on June 5 that James William Dukes, 29, of Anna, has been sentenced to three years in the Illinois Department of Corrections, with an impact incarceration recommendation, on one count of aggravated battery, which is a Class 2 felony.

Dukes will serve a twoyear period of mandatory supervised release.

### Anna City Council covers wide range of topics at regular meeting on June 5

covered a wide range of topics at a regular meeting which was held last week.

Topics of discussion included business growth and development, including a project in east Anna, flooding on East Vienna Street during heavy rainfall, the cost of fire calls, work is planned at the four-way stop in the heart of the Union County community and the recent installation of security cameras at the Anna City Park.

The meeting was Tuesday evening, June 5, at Anna City Hall.

City administrator Steve Guined reported that progress is moving quickly on the development of a project along Illinois Route 146 in east Anna.

The project includes a business which would be like a general store that is to be built on a site which covers about 11 acres. Other development also is planned at the site.

In another matter, the city administrator said that he would welcome feedback from the council regarding action which could be taken to resolve flooding issues which frequently occur in the 500 block of East Vi-

The Anna City Council enna Street during heavy rainfalls.

> The issue, which involves a state highway, has been an ongoing concern for at least a half a dozen years. The flooding is related to a collapsed culvert.

> Guined said he has discussed the matter many times with state officials, including legislators. No action has been forthcoming, he said.

> "It's getting worse," Guined said, who added that "it's not going to get

> The city administrator also shared an update on plans for work scheduled at the four-way stop in the heart of Anna. Major construction work is planned.

The work had been scheduled to start in mid-June. The Illinois Department of Transportation project will require the intersection to be closed for seven days.

As of last week, it appears that there may be a delay in the start of the project, Guined reported. The delay is related to insurance matters.

Anna Police Chief Mike Hunter reported that the recent installation of security cameras at the city park has proven to be beneficial.

Another incident involved vandalism at the new concession stand at the park.

Hunter said that both matters have been referred to the Union County state's attorney's office.

The possible granting of two general use liquor licenses also was discussed at the June 5 meeting.

In both cases, granting of the licenses would involve business growth and development.

In other business at the the meeting:

Anna Police Chief Hunter and Anna Fire Chief Gary Rider discussed a review of fees for fire calls which is underway.

City attorney John Foley shared concerns about the use of the golf carts for transportation. Increased use of such vehicles is anticipated with the arrival of warm weather.

Foley would like the city to alert the community about the regulations related to the use of such vehicles.

The city administrator reported that Anna is in the process of unveiling a

In one case, an incident new website. He praised city staff members and local vendors who have been helping with the project.

The website will offer users an opportunity to sign up for email alerts on

important topics. Posting of a clerical foreman's position was approved.

The city administrator discussed a recommendation presented by the Illinois Environmental Protection Agency that action be taken regarding the installation of backflow preventers on sewer lines.

The EPA recommendation would involve modification of existing city regulations and would suggest that such equipment should be installed, but would not be mandatory.

The city administrator also reported that work continues on the process leading to the final closure of the municipal landfill site, which is located along Kaolin Road north of Anna.

Guined said he is hoping that the 15-year closing process will come to a conclusion by December. The process involves the drilling of testing wells which will allow for the monitoring of ground water.

### Cold April, warmest May on record

Wondering what happened to spring this year? The National Weather Service office in Paducah is

Despite temperatures averaging near normal across the region for the season, this spring was anything but normal when you look at the individual months in Southern Illinois, Southeast Missouri and Western Kentucky.

March was the only month that was anywhere near what you would typically expect, with temperatures averaging slightly below normal.

As the region progressed into April, many of the days March.

In fact, it was one of the coldest Aprils on record across the area, with some locations experiencing their coldest April on record.

The region even had measurable snow in April for the first time since 1983 in several communities.

Then May 1 came, and temperatures suddenly warmed up quite abruptly.

A flip in the weather pattern resulted in above normal temperatures occurring on every single day of the month of May.

The end result was one of the warmest Mays on record across the region.

Paducah was one of many cities that experienced their warmest May on record. It literally felt more like you would expect in June.

"So essentially we flipped the switch and went straight from March to June, skipping April and May and all the nice mild weather that typically occurs in those months," the weather service shared on its website.

As for precipitation, it was generally a wet spring for a large portion of the region. This was particularly the

case from Perry and Jackson counties in Southern Illinois, southeastward into the Jackson Purchase area of Western Kentucky.

There were some locations that were drier than normal, including across much of the Missouri Ozark counties (Carter, Ripley Wayne) and up along the Interstate 64 corridor in Illinois.

Portions of Wayne and Jefferson counties in Southern Illinois observed less than 10 inches for the season, compared to many locations observing 14 to 17 inches.

Seasonal snowfall was generally above normal across the region. Many locations even observed measurable snow in April for the first time since 1983. including Paducah.

#### May: Temperatures Well Above Normal

During May, temperatures were well above normal, ranging from 7 to 8 degrees above normal across the region.

Paducah observed its warmest May on record, shattering the previous record set back in 1962. Around a dozen other

locations across the region also observed their warmest May on record.

Cape Girardeau had its second warmest May on record, behind 1962.

Temperatures were more reminiscent of June, with high readings consistently in the mid-80s to around 90 degrees. In fact, there have been

32 Junes dating back to 1938 that have been colder than May was in Paducah.

After a chilly April flipped on May 1 with all official climate stations registering above normal temperatures every single day of May.

Looking back at previous months, it appears the last time Paducah experienced a month in which every day was above normal was back in August 2007.

As for rainfall, it varied quite a bit across the region due to the nature of warm season precipitation.

Some locations would get dumped on while a couple miles down the road observed very little from an individual shower or storm.

Generally though, more areas experienced wetter than normal conditions for

This was especially true

across large sections of Western Kentucky and into Southern Illinois along and south of Route 13.

Portions of Southeast Missouri and up along the I-64 corridor in Illinois were drier than normal.

Parts of Jefferson and Wayne Counties in Illinois picked up less than 3 inches for the month, while many locations across the region observed 5 to 8 inches.

May is typically an active

severe weather month in our region, but this year it was fairly quiet. There were several days

that felt more like March when scattered thunderat times the switch was storms resulted in a few large hail or damaging wind

However, the only really active day came on the last day of the month.

Several rounds of storms impacted the region on May 31, with the first causing widespread damaging winds as a line of storms moved through areas of Southern Illinois along and north of Route 13 during the morning and early af-

ternoon hours. Several more waves of storms during the afternoon and evening hours were accompanied by large hail, damaging winds, flooding and a few tornadoes.

The remnants of tropical storm Alberto impacted the region as well May 28-30, a rare occurrence for so early in the season.

Biographies of each of the four veterans were shared in the program for the ceremony.

#### Adam Clapp

Adam Clapp was born on Dec. 10, 1754, in Guilford County, N.C.

He volunteered for service in the fall of 1776 and served as a private under Capt. Henry Whitesell and Col. Alexander Martin.

During this period, under Gen. Rutherford, he campaigned in what was then referred to as the Cherokee Nation and was engaged in several skirmishes with British Loyalists.

Clapp went on to serve again with Whitesell during another period of service, and with Capt. Eli Newland and Col. William O'Neal following the battle of Guilford Courthouse.

After his discharge from service, Clapp moved to Union County. He died on Aug. 15, 1841.

#### Jacob Hileman

Jacob Hileman was born on July 20, 1762, in Northampton County, Pa.

As a private in the 4th Company, 3rd Battalion, Northampton County Militia in 1778, he served under Capt. John Horner and Col. Michael Pobst.

In 1780, he served again as a private in the Northampton County Militia in the 4th Company, 6th Battalion, until Oct. 26.

Hileman completed his service in 1782, serving under Capt. Andrew Dapper and Lt. Col. Henry Geiger.

Jacob Hileman died on Aug. 25, 1828, in Union County.

#### **Christopher Lyerle**

Christopher Lyerle was born in 1763 in Virginia. He enlisted during the

year 1780 for a period of 18 months in Col. McRea's 10th North Carolina Regiment.

At the completion of his 18-month enlistment, he moved to Union County. He died on Sept. 30, 1832.

#### **Peter Meisenheimer**

Peter Meisenheimer was born in Philadelphia County, Pa., in 1755.

He volunteered for service in 1781 and served as a private in Mecklenburg County, N.C., for the North Carolina Continental Line under Capt. John Steirns.

Meisenheimer went on to serve in Col. Francis Lock's regiment at the Haw River, Buffalo Creek and Rock River in Montgomery County.

Following his discharge from service, he moved to Union County. He died in 1835.

Biographies of the patriots were compiled from records of the Sons of the American Revolution, Daughters of the American Revolution, the Union County Courthouse in Jonesboro and the book titled "Revolutionary War Pioneers," compiled by author and local historian Darrel Dexter, who was among those in attendance at Saturday's ceremony.

The marker now on display at the cemetery was made possible by a grant from the George Washington endowment fund, Sons of the American Revolution, and contributions from the Illinois Society and Long Knives Chapter, Sons of the American Revolution.

Organizers of the ceremony voiced their appreciation for help and support which were provided by the Daniel Chapman Chapter NSDAR, Rendleman & Hileman Funeral Home, St. John's Lutheran Church, the Union County Sheriff's Office and the Dongola Community Center.



The original Remember the Removal Bike Ride was held in 1984, and the leadership program resumed as an annual ride in 2009.

Participants are learning about the Cherokee Nation's history, language and culture and are getting a glimpse of the hardships their ancestors faced while making the journey on foot.

Starting in 1838, Cherokees were rounded up and forced from their homes in Georgia, Tennessee and other southeastern states to the Cherokee Nation's current capital in Tahlequah.

Of approximately 16,000 Cherokees who were forced to make the journey to Indian Territory, about 4,000 died from disease, starvation and exposure to the elements.

During the bitter winter of 1838-1839, more than 3,000 Cherokee were reported to have camped in the area where the Camp Ground Church and Cemetery now stand.

The cyclists are scheduled to travel through Georgia, Tennessee, Kentucky, Illinois, Missouri, Arkansas and Oklahoma.


### **Obituaries**



### "The Preaching Pen" 🔎 What Has Happened to Patience?



"Lord, send this young man tribulation in the morning; send this young man tribulation in the afternoon; send this young man tribulation in the evening...



#### Displaying the Flag

On Same Staff - U.S. flag at peak, above any other flag.

All persons present in uniform should render the military salute. Members of the armed forces and veterans who are present but not in uniform may render the military salute. All other persons present should face the flag and stand at attention with their right hand over the heart, or if applicable. remove their headdress with their right hand and hold it at the left shoulder, the hand being over the heart.

#### **Special Rules**

Do not let the flag touch the ground.

Do not fly flag upside down unless there is an emergency. Do not carry the flag flat, or carry things in it.

Do not use the flag as clothing.

Do not store the flag where it can get dirty.

Do not use it as a cover.

Do not fasten it or tie it back. Always allow it to fall free.

Do not draw on, or otherwise mark the flag.

#### Elvira, the County's **Second County Seat**

The first Court was held at the house on Bradshaw Creek. It was a convenient but possibly not too comfortable arrangement that the Court conducted its business. Two other counties had the same type of uncomfortable arrangement, those of Madison and St. Clair. Later in the year of 1813, on December 10th, the Territorial Legislature issued an order to create a more permanent arrangement for these counties to hold Court.

The Commissioners Record, dated January 12, 1814 states: "Ordered that the Clerk of this Court do issue a notice to Owen Evans, James A Whiteside and Jonas Hibbs commissioners for fixing the seat of Justice for this county and put the same in the hands of James Cochran or some other constable or special agent appointing them to meet on Wednesday the 19 inst. at the Court house in this county for the purpose of fixing on the same agreeably to an act of the Legislature of this Territory"

The men appointed acted quickly, meeting on the 19th of January, and returning with their report on March 26, 1814.

"We the undersigned Commissioners appointed by the General Assembly of this Territory for the purpose of fixing the seat of Justice in the county of Johnson having met on Wednesday the 19th day of January 1814 at the house of John Bradshaw within the said county did then and there proceed to ascertain the center of said county acted by the General Assembly thereof for fixing

in the several counties – and after mature deliberation and circumspection have finally fixed and determined upon the following place as the most proper convenient and eligible for the same. Towit at or near a certain spring on Lick Creek about one mile above the waggon ford on said creek where the road leading to Fergusons ferry crosses the said creek and which said spring is within the 5th section of Township 12 and Range 2 East of the meridian line and in the SW corner of said section. Given under our hands and seals this 21st day of January 1814" (Their signatures follow).

The area chosen for the permanent county seat did not have a name when plans to move there were being made. The first time the records indicate the new site's name was March 26, 1814, when "Elvira" was used in a report concerning building a jail at the site.

There was no town at site before Johnson County decided to put their seat of Justice there. This is easily seen in the original report where the commissioners simply referred to it as, at first, a spring, then gave more specific location for it, never once calling it by any name.

The first building necessary and the first attended to was a courthouse. A contract was let the same day to the highest bidder, that being William Simpson, for building a log courthouse. There was no indication as to the size of the building but Chapman does say, and we believe it is from the memories of people who had seen the building, "It was a large hewed log house, thirty or forty feet long, with a fire place in each end."

Almost as important, was a jail, which the county had not had up to this time. That contract was let the same day, Marvin Fuller, being the lowest. It was to have a room for criminals which may indicate that it had two rooms. Further details indicate that it had a door as well as a trap door. This may reinforce the idea of two rooms, one for unknown purposes and one for criminals with the entrance to this room via a trap door, most likely in the ceiling.

One additional structure was the building of a stray pen. This order was given on May 12, 1814. 
Residents of Union County need not go out of town for excitement and fun on the Fourth of July! There will be plenty of entertainment at the Anna City Park for all.



### '...the flag of the United States...

"That the flag of the United States shall be of thirteen stripes of alternate red and white, with a union of thirteen stars of white in a blue field, representing the new constellation."

This was the resolution adopted by the Continental Congress on June 14, 1777.

The resolution was made following the report of a special committee which had been assigned to suggest the flag's design.

A flag of this design was first carried into battle on Sept. 11, 1777, in the Battle of the Brandywine.

The American flag was first saluted by foreign naval vessels on Feb. 14, 1778, when the Ranger, bearing the Stars and Stripes and under the command of Capt. Paul Jones, arrived in a French port.

The flag first flew over a foreign territory in early 1778 at Nassau, Bahama Islands, where Americans captured a

Observance of the adoption of the flag was not soon in

coming, however.

Although there are many claims to the first official observance of Flag Day, all but one took place more than an entire century after the flag's adoption in 1777.

The first claim was from a Hartford, Conn., celebration during the first summer of 1861.

In the late 1800s, schools all over the United States held

Flag Day programs to contribute to the Americanization of immigrant children, and the observance caught on with individual communities.

The most recognized claim, however, comes from New York.

On June 14, 1889, Professor George Bolch, principal of a free kindergarten for the poor of New York City, had his school hold patriotic ceremonies to observe the anniversary of the Flag Day resolution.

This initiative attracted attention from the state Department of Education, which arranged to have the day observed in all public schools thereafter.

Soon the state legislature passed a law making it the responsibility of the state superintendent of public schools to ensure that schools hold observances for Lincoln's birthday, Washington's birthday, Memorial Day and Flag Day.

In 1897, the governor of New York ordered the displaying of the flag over all public buildings in the state, an observance considered by some to be the first official recognition of the anniversary of the adoption of the flag outside of schools.

Another claim comes from Philadelphia. In 1893, the Society of Colonial Dames succeeded in getting a resolution passed to have the flag displayed on all of the city's public buildings.

Elizabeth Duane Gillespie, a direct descendant of Benjamin Franklin and the president of the Colonial Dames of Pennsylvania, that same year tried to get the city to call June 14 Flag Day.

Resolutions by women were not granted much notice, however, and it was not until May 7, 1937, that Pennsylvania became the first state to establish the June 14 Flag Day as a legal holiday.

Flag Day is a nationwide observance today, but Pennsylvania is the only state that recognizes it as a legal holiday.

Bernard J. Cigrand, a school teacher in Waubeka, Wis., reportedly spent years trying to get Congress to declare June 14 as a national holiday. Although his attempts failed, the day was widely observed.

"Father of Flag Day" honors have been given to William T. Kerr, who was credited with founding the American Flag Day Association in 1888 while still a schoolboy in Pittsburgh, Pa.

Both President Wilson, in 1916, and President Coolidge, in 1927, issued proclamations asking for June 14 to be observed as the National Flag Day.

But it wasn't until Aug. 3, 1949, that Congress approved the national observance, and President Harry Truman signed it into law.

### New budget places state on strong fiscal footing

After months of ongoing negotiations, Illinois lawmakers set aside partisan agendas and came together to pass a budget that rejects the irresponsible practices that have dominated state spending for over a decade.

On June 4, a new \$38.5 billion state budget was signed into law, providing a responsible plan for the upcoming fiscal year and ensuring that Illinois starts down the road to financial recovery.

After enduring an unprecedented budget crisis last year that collapsed into yet another out-of-balance budget that burdened our taxpayers with a massive tax hike, the people of this state were left frustrated and defeated.

For too long, Illinois operated under state government leaders who refused to control their spending and keep their hands out of the pockets of our taxpayers. Enough was enough.

This budget is a spending proposal that I believe places Illinois on strong fiscal footing to begin moving forward. Additionally, we are seeing a reaffirmed commitment to higher education, directing additional funds toward operation costs across-the-board that will help keep our universities and colleges strong.

What we've accomplished with this budget is a platform to build from, providing a starting place for recovery in our state. It isn't perfect and the work doesn't end here.

We'll have to work each and every day to ensure that this budget remains balanced. We must continue to fight for the critical reforms needed to protect our taxpayers, help our businesses and provide for our students. I know that Illinois is worth that fight, and I will continue to work to give our state a better and brighter future.
