Items of interest from throughout the Union County area

Shawnee Community College planned to announce its next president Tuesday evening, Sept. 8.

The Union County Sheriff's Office and the Anna Police Department both reported that the Labor Day holiday weekend was pretty quiet.

The Jackson County Health Department on Friday, Sept. 4, reported a daily record of 49 new COVID-19 cases.

Shawnee Community College's "Late Start" classes were scheduled to begin Sept. 8.

The rescheduled 2020 Shawnee Hills Pottery Trail event is planned Saturday and Sunday, Sept. 26-27, in Union and Jackson counties. The event had been planned in the spring, but was postponed due to the pandemic.

Friday, Sept. 11, is Patriot Day.

Sunday, Sept. 13, is Grandparents Day.

The first day of autumn is Sept. 22.

An "It's Fall Ya'll" event is planned Saturday and Sunday, Sept. 12-13 in Cobden. The Union County Museum Shop and Packrats Paradise are participating.

A fall curbside cleanup day is planned Oct. 14 in the Village of Cobden.

The Gazette-Democrat is planning to publish its annual tribute to veterans section on Oct. 29.

County continues at COVID-19 warning level

The Illinois Department contacts or answering the of Public Health, IDPH, on Friday, Sept. 4, reported 29 counties in Illinois are considered to be at a warning level for novel coronavirus disease (COVID-19).

Union County remained at the warning level for another week.

A county enters a warning level when two or more COVID-19 risk indicators that measure the amount of COVID-19 increase.

As of Friday, 29 Illinois counties were reported to be at a warning level:

Union, Boone, Bureau, Clinton, Coles, Cumberland, Edgar, Effingham, Fayette, Greene, Henry, Jasper, Jefferson, Jersey, Lake, Lawrence, Madison, McLean, Monroe, Pulaski, Randolph, Rock Island, Shelby, Stark, St. Clair, Wabash, Warren, Williamson, Will.

Although the reasons for counties reaching a warning level varies, IDPH reported that some of the common factors for an increase in cases and outbreaks are associated with college parties, weddings, large gatherings, bars and clubs, long-term care facilities and other congregate settings, travel to neighboring states, and spread among members of the same household who are not isolating at home.

Cases connected to schools are beginning to be reported. General transmission of the virus in the community is also increasing.

Public health officials said they are observing people not social distancing, gathering in large groups and not using face cover-

In some counties, local law enforcement and states' attorneys are not enforcing important mitigation measures like social distancing and the wearing of face coverings.

Additionally, IDPH said that some people refuse to participate in contact tracing and are not providing information on close

phone.

Individuals are also waiting to get tested believing their symptoms are allergies or some other cause.

Several counties are taking swift action and implementing mitigation measures to help slow spread of the virus, including increasing testing opportunities, working with schools, meeting with local leaders, and educating businesses and large venues about the importance of mitigation

IDPH uses numerous indicators when determining if a county is experiencing stable COVID-19 activity, or if there are warning signs of increased COVID-19 risk in the county.

A county is considered at the warning level when at least two of the following metrics triggers a warning.

New cases per 100,000 people. If there are more than 50 new cases per 100,000 people in the county, this triggers a warning.

For the period of Aug. 23-29, Union County had 184 new cases per 100,000 people, which triggered a warning.

Weekly test positivity. This metric indicates a warning when the sevenday test positivity rate rises above 8 percent. Union County had a rate of 12.2, which triggered a warning.

Tests performed. This metric is used to provide context and indicate if more testing is needed in the county. Union County had 295, which was at the warning level.

Number of deaths. This metric indicates a warning when the weekly number of deaths increases more than 20 percent for two consecutive weeks. Union County had one death.

ICU availability. If there are fewer than 20 percent of intensive care units available in the region, this triggers a warning. Union County had 56.3 percent available.

Drive-thru COVID-19 testing offered

Southern Seven Health Department offered free drive-thru coronavirus/ COVID19 testing on Saturday, Sept. 5, in Union County. The testing was available at the health department's location along Lick Creek Road in Anna. A steady stream of vehicles was on hand. Working together, Southern Seven Health Department, the Illinois Department of Public Health and HR Support offered the free testing. Samples were obtained by swabbing both nostrils of those who came for the testing. The samples were sent to Reditus Laboratories in Pekin. The samples were expected to be in Pekin by Saturday night, with results made available within four to seven days.

Union County up to 430 cases

Southern Seven Health Department on Friday confirmed a total of 14 new cases of COVID-19 in the region it serves in Southern Illinois.

Four of the new cases were in Union County.

The health department reported that the newly confirmed cases, by county, gender and age, included:

Union County: two males in their 10s, one male in his 40s, one female in her 50s.

Johnson County: one female in her 10s, one female in her 20s, one female in her 30s, one male in his 40s.

Massac County: one male under 5, one female in her 60s, one female in

Pope County: one male in his 30s.

Pulaski County: one female in her 10s, one male in his 10s.

The health department reported five new recovered cases of COVID-19 in its service area as of Sept. 4.

As of Sept. 4, there were 673 people in the health department's service area who had recovered since the start of the pandemic in the United States.

Also as of Sept. 4, the health department was reporting a cumulative total of 852 cases of COVID-19 in its service area. There were 152 active cases in the region.

The health department confirmed that a total of 12,052 negative COVID-19 tests had been reported in the region as of Aug. 28.

Twenty-four deaths had been reported in the region since the start of the pandemeic.

Union County had a total cases of COVID-19 are Seven Health Department as of Sept. 4 follows:

Union County: 430 cases. 347 had recovered. 60 active cases. 20 deaths had been reported in the county. (The department noted that three deaths had been retracted in the county.)

Alexander County: 47 cases. 38 had recovered. Eight active cases. One death had been reported.

Hardin County: 20 cases. 18 had recovered. Two active cases.

Johnson County: 127 cases, 92 had recovered, 35 active cases.

Massac County: 70 cases. 48 had recovered. 21 active cases. One death had been reported.

Pope County: 20 cases. 13 had recovered. Six active cases. One death has been reported in the county.

Pulaski County: 134 cases. 117 had recovered. 20 active cases. One death had been reported in the county.

Quilts of Valor is a nonprofit foundation which was started in November 2003 with one quilt made by a Blue Star mom Catherine



Her goal was to make quilts that "would both heal and comfort."

Quilts of Valor notes that many of the nation's service members return home with unseen wounds. The mission of the foundation has been, and continues to be "to cover all active service members and veterans with comforting and healing **Quilts of Valor.**"

The foundation says that "no matter where we stand politically, we accept our warriors and veterans with open arms and open hearts. One only has to talk to the veterans of previous wars and conflicts to get a glimpse that the profound effects of war never really leave."

Each Quilts of Valor creation consists of three layers.

The top of the quilt: With its many colors, shapes and fabrics, the top of the quilt represents "the many different individuals we are."

The batting is the center: The batting's warmth represents "our hope that this quilt will bring comfort, peace and healing to the individual receiving it."

The backing: The backing is the strength which supports the other layers. The backing represents the strength of the recipient, the support of his or her family, "all of our communities and our nation."

"And let's not forget the stitches that hold the layers together," Fisher shared. "These represent the love and gratitude we hold in our hearts for you."

"We want this quilt to bring you this message: We honor you for your service. We honor you for leaving

all you hold dear to stand in harm's way in a time of crisis, protecting us from the effects of war," she continued.

"We know that freedom is not free. The cost of freedom is the dedication of lives of men and women like you and this quilt is meant to say thank you for your sacrifice.

"And finally, this quilt is meant to offer comfort to you and to remind you that although family and friends cannot be with you at all times, you are forever in our hearts.

"For those of us who have never seen combat or been in a war zone, these experiences are far beyond our capacity to comprehend. We believe that as we sew, caring and gratitude flows from our hearts and through our hands into the quilts. There is not a hug strong enough - there are not words big enough. All we can offer is thank you."

At this point, each veteran who was to be honored came forward and was presented with his Quilt of Valor.

Each quilt was unfolded and carefully wrapped around the veteran.

The veterans who were recognized Monday included Matthew Johnson of Tunnel Hill, Ronald Howard of Stonefort, Charles Robinson of Harrisburg, Charles Patton of Anna, Mark Chancey of Ridgway and Randal G. Weber of Hurst (who was not able to be present). Each veteran who received a quilt voiced his thanks and appreciation.

Fisher closed the ceremony with these words:

'This quilt is the highest honor that we as ordinary individuals can bestow upon you. Please keep it with you as a tangible reminder that there are thousands of women and men across this land that are forever in your debt. Your Quilt of Valor may have been sewn by only one or two individuals or through the combined effort of many women and men.

"All Quilts of Valor awarded have a Quilts of Valor label on the back of the quilt with the recipient's name, date of award and the makers of the quilt.

"We hope that this quilt will become your legacy, to be passed down to future generations in your family, so they will know of your sacrifice to defend and keep not only their country free, but the freedom of others around the world. I am proud to say that we have covered over 254,000 of our military with Quilts of Valor. We have many, many more service members to cover - and we can only do it one quilt at a time. One quilt today is one veteran that wasn't honored yes-

"We will never know the depth of your sacrifice to protect and defend the United States of America, but as a gesture of gratitude from a grateful nation, I ask that you please accept your Quilt of Valor. It is a great privilege and my pleasure to be able to present you with your Quilt of Valor. Thank you for your

Weekly emergency department visits. This metric indicates a warning when the weekly percent of COVID-19-like-illness emergency department visits increase by more than 20 percent for two consecutive weeks.

Weekly hospital admissions. A warning is triggered when the weekly number of hospital admissions for COVID-19-likeillness increases by more than 20 percent for two consecutive weeks. If there are fewer than five emergency department visits for CLI for seven days, then the percent is not calculated, due to the small number instability in the percent.

Clusters. This metric

looks at the percent of CO-VID-19 cases associated with clusters or outbreaks and is used to understand large increase in cases. Union County had 0 per-

IDPH said the metrics are intended to be used for local level awareness to help local leaders, businesses, local health departments, and the public make informed decisions about personal and family gatherings, as well as what activities they choose to do.

The metrics are updated weekly, from the Sunday-Saturday period of the prior week.

A Sept. 30 deadline to will be provided. A Spanish respond to the 2020 nationwide census is fast approaching.

As the deadline draws closer, a Union County Census Day is planned Thursday afternoon, Sept. 17, in Anna.

Census Day activities are scheduled from 2 p.m. to 6 p.m. on the front lawn at Stinson Memorial Library. The library is located at 409 S. Main St.

The free event will be sponsored by the City of Anna and Union County, and will be supported by the Illinois Migrant Council, the Village of Cobden, the Village of Dongola, the City of Jonesboro, the Shawnee Mass Transit District, Southern Seven Health Department and the Southern Five Regional Planning Commission.

Shawnee Mass Transit District has partnered with Union County Census Day organizers to offer free rides to and from the event within the county. Rides can be scheduled by calling 1-866-577-6278.

Organizers note that there will be several computers available at the event that can be used for submitting the 2020 census electron-

Questions about the census can be answered. Assistance in filling out the census translator is scheduled to be present.

Union County Census Day will feature free food, many giveaways, fliers and information, along with a \$50 gift card drawing for those who submit their survey at the event.

Southern Seven Health Department has been working to promote participation in the 2020 census in the Southern Illinois counties which it serves.

As of last week, the health department reported that just a little over half of the residents in the seven southernmost counties of Illinois had completed their census.

In 2010, the region missed out on more than \$12.5 million. The region stands to lose even more this time, the health department advised.

As of Sept. 2, the health department reported that Union County had a census response rate of 66.9 percent. That was down from 68.8 percent in 2010.







Legislation addresses mental health issues for vets

Bipartisan legislation has been introduced in Congress to help the U.S. Department of Veterans Affairs better identify veterans facing higher mental health

The legislation was introduced by U.S. Rep. Mike Bost, R-Ill.

Bost said the VA Precision Medicine Act would require the agency to implement an initiative that identifies brain health biomarkers.

The goal would be to help determine which veterans are at higher risk for depression, post-traumatic stress and other threats to mental health.

Bost said the legislation also requires the VA develop data privacy and security measures to ensure that veterans' information remains private and secure.

"We lose 20 service members to suicide a day," Bost said in a news release.

"We need to find new ways to address this crisis. Modern medicine and scientific research have made it possible to identify patients who are at a higher risk of developing cancer, dementia, or even depression.

"This important legislation requires the VA to implement these medical advances in order to better identify veterans who may be more likely to develop depression or PTSD.

"If we can get these veterans the care they need sooner, then it is less likely that tomorrow they will become one of the 20."

State Supreme Court: Masks 'should be worn at all times' in Illinois courtrooms

SPRINGFIELD - I1linois' highest court on Thursday, Aug. 27, included wearing a face covering in its COVID-19 rules governing state courthouse admittance.

The update comes six days after Gov. JB Pritzker issued his seventh disaster proclamation in response to the novel coronavirus pandemic and reflects the Supreme Court's first direct mention of masks since its March 17 guidelines were issued.

Now, those who work or have business at a state court building "should not enter any courthouse" without a face covering.

Masks "should be worn at all times" unless the individual is younger than 2 years old, experiencing breathing trouble or is given different instructions by an official.

Other reasons Illinois-

ans should not access a courthouse, according to the guidelines, include having COVID-19 or flu-like symptoms and a temperature of 100.4 degrees or

Also, residents who were instructed to remain at home for isolation or quarantine by a health professional, or who live or have close contact with someone who has, "should not" enter a state court building.

The Illinois Supreme Court has authority over all state courts, thus making these rules applicable statewide.

Its updated guidelines were also issued two days after Pritzker issued stricter face covering mandates for bars and restaurants as the state's confirmed COVID-19 cases continued to increase.

Customers of such establishments now are required to wear a mask when interacting with staff.






3. Resolve to do more for others. Be more of a peacemaker (Mt. 5:9).

Drivers license renewal extended for Illinois seniors ages 75, older

Jesse White has announced that the expiration date for valid driver's licenses held by the state's drivers who are 75 years of age or older has been extended for a period of one year past the licenses' current 2020 expiration date.

As a result, drivers age 75 and older with a 2020 driver's license expiration date do not need to visit a facility to renew their driver's license until shortly before their birthday in 2021.

"I am mindful of the heightened risks associated with seniors contracting COVID-19, and that is why I have authorized this important change during this challenging and unique time," White said in a news

White said the letter should be kept with the qualifying driver as further proof of the one-year ex-

In addition, driving records on the Illinois Secretary of State's computer system have been updated to show the new 2021 expiration dates for qualified drivers, and law enforcement agencies both state and nationwide have been notified of the extended expiration dates.

In addition to being 75 years of age or older, the driver must have a valid license; drivers who are suspended or revoked do not qualify for the one-year

White is reminding all other drivers that expiration dates for driver's licenses/ ID cards and license plate stickers have been extended until Nov. 1, 2020.

As a result, expired documents will remain valid until Nov. 1, so customers under age 75 do not need to rush into driver services facilities, especially during hot weather.

For those customers who must visit a facility, face masks are required.

In addition, these customers are asked to be patient due to heavy volume and to be prepared to wait outside in various types of weather.

This is due to social distancing, which limits the number of people inside a facility at one time.

White continues to urge the public to consider using online services when possible instead of visiting a facility due to heavy customer volume.

Customers who can conduct business online may go to www.cyberdriveillinois.com to take advantage of online services, such as renewing license plate stickers, from the comfort of their own home.

People who conduct online transactions will avoid waiting in line at a facility.

State law gives the Illinois Secretary of State the authority to extend driver's license expiration dates by up to one year.





Public health officials: vaccinations important for children and adults

Although school looks different this year because of coronavirus disease 2019 (COVID-19), whether it's remote learning, in the classroom, or a hybrid, kids should still receive their routine vaccinations, public health officials say. Vaccines help to protect children from diseases like chickenpox and pertussis, which remain common in the U.S.

"While much of our focus is on COVID-19 these days, we must continue to take care of all of our health needs,' said Illinois Department of Public Health, IDPH, director Dr. Ngozi Ezike.

"Vaccines are one of the safest and most effective methods to protect children from more than a dozen vaccine-preventable diseases. Make sure your children are fully vaccinated so they can be as healthy as possible while facing the ongoing risk of COVID-19."

IDPH has teamed up with the Illinois Chapter of the American Academy of Pediatrics, ICAAP, on a social media campaign that is designed to raise awareness of the importance of vaccines.

"Missing well-visits and vaccines place children at higher risk for more problems in the future. Especially during the onset of COVID-19, vaccines are the best way to keep children protected and healthy," said Dr. Mariana Glusman, immediate past president of the Illinois chapter of the American Academy of Pediatrics. "This campaign aims to increase awareness about the importance of immunizations and routine visits for children."

The immunization requirements for the 2020-2021 school year are the same as last year. The requirements can be found on the IDPH website under immunizations.

Vaccines are not just for kids, however. Vaccines are recommended throughout our lives. IDPH is asking everyone to check their vaccination history and talk with their health care provider.

Adults should get a flu vaccine each year and receive a Td (tetanus and diphtheria) booster vaccine or Tdap (tetanus, diphtheria, pertussis) every 10 years. Tdap is also recommended for pregnant women during each pregnancy.

Adults 50 years and older are recommended to receive the shingles vaccine. Adults 65 and older are also recommended to receive both pneumococcal vaccines, although one year apart.

Some adults younger than 65 years with certain conditions are also recommended to receive one or more pneumococcal vaccinations.

Adults may need other vaccines (such as hepatitis A and B) based on age, pregnancy status, occupation, travel, medical, and vaccination history, and/or other considerations.

Snake Road at LaRue-Pine Hills closed for annual migration

known as Snake Road, is closed to help ensure safe crossing for several species of snakes and amphibians during their critical time of migration.

The Union County road is closed in the fall and the spring by the U.S. Forest Service. The road is north of Wolf Lake.

The 2.5-mile-long road closes the week of Sept. 1 through Oct. 30 to allow snakes and amphibians to migrate from their summer habitat in the LaRue Swamp across the road to their winter habitat in the nearby limestone bluffs.

The gradual, two-month migration event attracts people

Twice each year, Forest Service Road No. 345, also from across the country eager to witness the rich diversity of reptile and amphibian species along this single stretch

> About 66 percent of the amphibians and 59 percent of the reptiles known to occur in Illinois are found in the LaRue-Pine Hills area.

> Though the road is closed to vehicles, it is open to people traveling on foot.

> Special regulations apply to the area. LaRue-Pine Hills/ Otter Pond is a federally designated Research Natural Area. Unauthorized collecting and handling of any of the species is prohibited under federal and state law.
