inter storm brings snow, arctic cold to area

Bitter cold temperatures and snow late last week in the region were followed by two more rounds of wintry precipitation on Monday.

Local weather observer Dana Cross recorded a total of 6 1/2 inches of snow in Jonesboro, including 2 1/2 inches on Dec. 22 and 4 inches on Dec. 26.

Last week's snow meant that Union County had a white Christmas - while coping with subfreezing temperatures and wind chills in the range of 30 degrees below zero.

On Dec. 22, the temperature dropped from a high of 44 degrees to a low of 4 degrees below zero.

The low temperature was 6 degrees below zero on Dec. 23. The high that day

grees below zero was recorded at 12 a.m. on Dec. 23.

Warm Up Expected

As 2022 comes to an end much milder temperatures are in the forecast for the region. The new year begins Sunday, Jan. 1.

High temperatures are forecast to be in the 50s on Thursday (today), Friday, Saturday and Sunday (New Year's Day). Rain is possible today, Friday, Saturday and the first day of 2023.

The weather which impacted Union County just before Christmas was part of what the National Weather Service described as an historic winter storm which produced widespread disruptions to large portions

the holiday weekend.

Dangerous...Record-**Breaking Cold Air Mass**

The weather service warned on Thursday, Dec. 22, that the powerful storm was expected "to produce widespread disruptive and potentially crippling impacts across the central and eastern United States."

"Record-breaking cold and life-threatening wind chills" were expected to overspread the eastern half of the nation by Friday.

"At the forefront of the impressive weather pattern is a dangerous and recordbreaking cold air mass in the wake of a strong arctic cold front diving southward across the southern Plains today, and eastward into the Ohio/Tennessee Valleys

Immense Winter Storm The weather service reported early Friday morning, Dec. 23, that a powerful Arctic front was sweep-

ing across the eastern third

of the nation. The immense winter storm brought a frigid blast to much of the continental United States, along with impactful winter precipitation that continued to track across the eastern United

States on Friday. Winter weather hazards remained in effect from the Canadian border south to the Rio Grande, Gulf Coast and central Florida Peninsula while spanning from the Pacific Northwest to the Eastern Seaboard.

A wind chill of 24.3 de- of the nation heading into by tonight," the weather Service's Watch Warning graphic was depicting one of the greatest extents of winter weather warnings and advisories ever.

As of early Friday morning, over 240 million people within the United States were under some form of winter weather warning or advisory.

This included 181 million for wind chill warnings or advisories, over 11 million for a blizzard warning, 58 million for winter storm warnings and over 500,000 for ice storm warnings.

Travel was affected by the storm, and many power outages were reported.

The weather service warned that the system would have increasingly widespread impacts on (continued on page 2)

Wind chills well below zero in area

During the past week's blast of arctic cold, local weather observer Dana Cross recorded the following wind chills in Union County:

From 10:30 p.m. on Dec. 21 to 10 a.m. on Dec. 23, all of the recorded wind chills were 20 degrees below zero or colder.

From 4:30 p.m. on Dec. 22 through 8:30 a.m. on Dec. 24, all of the recorded wind chills were below zero.

Dec. 22, 11:30 p.m., 24.2 degrees below zero.

Dec. 23, 12 a.m., 24.3 degrees below zero.

Dec. 23, 7:30 a.m., 24 degrees below zero.

Dec. 23, 2 p.m., 23.5 degrees below zero.

23,793 new COVID-19 cases

As families across Illinois and the nation planned to celebrate the holiday season last weekend, COV-ID-19 and other respiratory viruses were circulating at concerning levels.

Ahead of the weekend, the Illinois Department of Public Health, IDPH, was reminding the public to celebrate the holidays safely and to take action to protect their most vulnerable loved ones, including the elderly and the very young.

IDPH director Dr. Sameer Vohra urged those who were feeling ill to take a COVID-19 test and to stay home if they test positive to avoid spreading the virus to friends and family, especially those vulnerable to serious outcomes.

IDPH also announced on

Friday, Dec. 23, that as of the end this year, it will follow the lead of the CDC and shift from daily reporting of new COVID-19 cases and deaths to a weekly reporting of the data.

Daily case and death data will no longer be reported as of Jan. 1, 2023.

Following that date, IDPH plans to report weekly data on Wednesday of each week for the previous week ending Sunday.

IDPH plans to continue to report ICU bed availability and hospital admission data on a daily basis.

The CDC announced it was making the shift from daily to weekly reporting of case and death data in October.

IDPH officials believe that weekly reporting will

provide the public with a more accurate picture of COVID-19 trends across the state over time by tracking cases and deaths by the week they arise, rather than the date they are reported, which may be days or weeks later.

According to the CDC, as of Friday, 88 counties in Illinois were rated at an elevated level for COVID-19 by the CDC, which was up from 86 a week earlier.

Of those, the CDC reported 33 Illinois counties at a high community level for COVID-19, down from 43 a week earlier.

The CDC reported that 55 counties were at a medium level, compared to 43 a week earlier.

Union, Alexander, Pulaski and Jackson counties were at a low community level as of Friday.

Williamson County was at a medium community level.

Johnson and Massac counties were at a high community level.

On Friday, IDPH reported 23,793 new confirmed and probable cases of CO-VID-19 in Illinois since Dec. 16, and 82 deaths.

'Illinois continues to see most of its communities at elevated risk levels for COVID-19, including 33 counties that are currently at high risk," director Vohra said.

'We are still seeing CO-VID-19 community levels, along with flu and other respiratory illnesses rise in many counties.

'Our goal is to limit hospitalizations, preserve hospital beds, and protect those most vulnerable to serious health outcomes, especially those over 65 and

very young children. 'These preventative measures start with being up-to-date with the CO-VID-19 bivalent booster and getting your flu shot,"

Vohra continued. "Other important protective steps include COV-ID-19 testing, especially if visiting someone at risk for severe disease; enhanced ventilation at gatherings; and good hand hygiene.

"And if you are sick, stay home and consult with your provider about whether you need one of the effective treatments that are available.

"A high-quality mask or respirator is also recommended and will protect you from COVID-19, the flu and other respiratory viruses. Our hope is for Illinoisians across our state to have a happy and healthy holiday weekend."

As of Friday, IDPH was reporting a total of 3,953,928 cases, including 35,714 deaths, in 102 counties in Illinois since the

beginning of the pandemic. Of Illinois' total population, more than 78 percent had received at least one COVID-19 vaccine dose, 71 percent had completed their primary series of COVID-19 vaccines and of the eligible population, more than 18 percent had received the bivalent booster dose, according to data from the Centers for Disease Control and Prevention. All data are provisional and are subject

to change.

(continued from page 1) travel going into the busy holiday travel time. Christmas was Sunday, Dec. 25.

The storm also was expected to cause more power outages due to expected high winds, heavy snows, significant icing and overall increased power consumption in some places.

The powerful front allowed temperatures to plummet 30 to more than 50 degrees over a short period for a vast portion of the country.

Widespread record low maximum temperature values were possible Friday from the Lower Mississippi Valley, northeastward into the Tennessee and Ohio Valleys and stretching across large sections of the east from the Southeast, through the Southern to Central Appalachians and into the Mid-Atlantic.

In addition to the very cold temperatures, high winds in the wake of the front produced dangerous wind chill readings across nearly all of the central to eastern United States.

Wind Chill, Winter **Storm Warnings**

The National Weather Service office in Paducah issued a wind chill warning for the region on Wednesday, Dec. 21. The warning was for parts of Southern Illinois, Western Kentucky and Southeast Missouri.

The weather service was advising that dangerously cold wind chills of 16 degrees below zero to 26 degrees below zero were possible as a result of Thursday night low temperatures near zero and sustained winds of 15 to 20 miles per hour,

mph. "Dangerously cold wind

chill values can quickly result in frostbite in as little as 30 minutes," the weather service warned.

The weather service issued a winter storm warning for parts of Southern Illinois and Southeast Missouri on Thursday, Dec. 22.

Heavy snow was expected, with total accumulations of 2 to 4 inches. Wind gusts of up to 40 mph were expected.

The storm arrived in the Union County area early Thursday afternoon, Dec. 22. Rain, sometimes heavy, fell initially. The rain gave way to snow.

Snow quickly covered area roads and highways. The Illinois Department of Transportation reported online that many roads in the state were either partly or mostly covered with ice or snow by late Thursday

The Illinois State Police on Dec. 21 asked the motoring public to stay off the roadways for the next couple of days during the severe weather.

Several rounds of snowfall kept road crews busy during the past week.

Union County Sheriff David Wilkins and Anna Police Chief Bryan Watkins said that no major traffic accidents were reported during the winter storm.

Scattered power outages also were reported in the area during the bitter cold.

The weather service office in Paducah issued a winter weather advisory for the region that was in effect from late Sunday night through midday on Monday. Snow was expected, with accumulations of up to 2 inches possible.

Overview of Winter

Storm

The weather service office in Paducah on Monday posted an overview of the impact of the Dec. 22-23 winter storm.

Snow amounts were reported to have been relatively light in the region, peaking at around 4 inches. Drifts from strong winds made the measuring of snow difficult.

Snowfall totals included 4 inches in Marion and

New Illinois laws take effect Jan. 1

SPRINGFIELD - By now, almost everyone in Illinois has heard that Jan. 1 will mark the beginning of a significant change in the state's criminal justice system – the elimination of cash bail.

It's an issue that dominated the 2022 campaigns and has been both praised and criticized on editorial pages in newspapers across the state.

It essentially means that starting Jan. 1, the decision as to whether a criminal suspect should be held in jail while awaiting trial will be based on public safety and the likelihood the suspect will flee rather than their financial ability to post bond.

And while that criminal justice reform has received widespread attention, it is by no means the only new law that will take effect when the calendar turns over to 2023.

For most people who work a minimum wage job, the new year will bring a pay raise to \$13 per hour, a \$1 increase over the current tax rate is supposed to take

That's the result of a law Gov. JB Pritzker signed in 2019, his first major legislative victory after being sworn into office a month earlier. The law will eventually raise the wage to \$15 an hour on Jan. 1, 2025.

The new \$13 hourly rate does not apply to all minimum wage earners. People who receive tips at work will see their base wage rise to \$7.80 an hour. And people younger than 18 who work fewer than 650 hours per year will see their wage go up to \$10.50 an hour.

The higher wage will probably come as welcome news for those who drive a car to and from work. That's because the new year will also bring higher motor fuel taxes.

The same year Pritzker signed the minimum wage bill, he also signed a multi-year, \$45 billion transportation and capital improvements bill known as "Rebuild Illinois," which is funded in part with higher motor fuel taxes that are scheduled to increase with inflation each year.

effect on July 1 of each year, the definition of when a the first day of the state's fiscal year. But last spring, in the face of rising inflation and healthy state revenues. lawmakers authorized a sixmonth delay in the scheduled increase, putting it off until Jan. 1.

As a result, starting Jan. 1, the motor fuel tax people pay at the pump will go up 3.1 cents per gallon, and then it will increase again when the next regular adjustment date comes around on July 1, 2023.

Criminal Law

Several new criminal laws will go into effect Jan. 1, including three that deal with sex offenses.

One of those prevents people who solicit sex from a minor or a person with a severe or profound intellectual disability from asserting a defense that they simply did not know the person was underage or intellectually disabled. House Bill 4593, signed into law May 27, puts the burden of proof on the defendant that they did not know the age or disability status of the other person, rather than the other way around.

Another new law changes

person is "unable to give knowing consent." Under current law, a person cannot give knowing consent when the accused person "administers any intoxicating or anesthetic substance or any controlled substance" that causes the victim to lose consciousness of the nature of the act.

House Bill 5441, signed June 16, broadens that definition to include when the victim has taken any intoxicating or controlled substance causing them to lose consciousness of the nature of the act, even if the substances were administered by someone else.

Another bill expands certain employment restrictions that apply to convicted child sex offenders. Currently, they are prohibited from being employed by, or even being present at, child day care centers, schools that provide before- and after-school programs for children or any facility that provides programs or services exclusively for people under age 18.

Senate Bill 3019, signed May 27, expands that to prohibit convicted child sex offenders from working at carnivals, amusement enterprises, county fairs and the state fair when people under age 18 are present.

Another new law expands the list of professionals who are required to report suspicions of child abuse or neglect. Starting Jan. 1, under Senate Bill 3833, signed May 13, occupational therapists and assistants, physical therapists and assistants, and athletic trainers will be added to that list.

Carjacking

Three new laws taking effect Jan. 1 are intended to address a spike in carjackings around the state. All were signed on May 26.

House Bill 601 expands the crime of possession of

burglary tools to include possession, with the intention to enter and steal a vehicle, of devices to unlock or start a vehicle without the key to that vehicle, or devices that capture or duplicate a signal from a key fob to unlock or start the vehicle.

House Bill 3699 expands an existing state council charged with providing grants and financial support to law enforcement agencies to aid in identifying, apprehending and prosecuting carjackers and recover stolen vehicles.

And House Bill 3772 ensures that victims of carjackings are not liable for costs and fines associated with impounding a vehicle that was stolen or hijacked, provided the owner files a police report in a timely manner.

Education

To address a shortage of substitute teachers throughout the state, House Bill 4798, signed April 27, allows students enrolled in approved teacher training programs who have earned at least 90 credit hours to obtain a substitute teaching license. Before, applicants had to hold a bachelor's degree or higher from an accredited institution of higher education.

House Bill 4716, signed May 27, calls on the Illinois State Board of Education to adopt "rigorous learning standards" for classroom and laboratory phases of driver education programs for novice teen drivers. Those will include, at a minimum, the Novice Teen Driver Education and Training Administrative Standards developed by the Association of National Stakeholders in Traffic Safety Education in association with the National Highway Transportation Safety Administration.

Higher Education

In an effort to get more people to pursue careers in human services, Senate Bill 3925, signed June 10, establishes a student loan repay-

ment program. Subject to appropriations, the Illinois Student Assistance Commission will award loan repayment grants to qualified individuals with an associate degree or higher who works for a human services agency that contracts with or is grant-funded by a state agency that provides 'direct or indirect services that ensure that individuals have essential elements to build and maintain physical, emotional, and economic well-being at every phase of life."

Awards can be made for a maximum of four years. Maximum amounts are \$3,000 per year for someone with an associate degree, \$15,000 per year for a person with a bachelor's degree and \$25,000 per year for a person with a master's degree or higher, with a \$5,000 per-year add-on if the applicant holds certain professional licenses.

Meanwhile, students currently enrolled in any program at a public university or community college will have access to trained individuals who can help them apply for federal, state or local assistance based on their financial need. House Bill 4201, signed June 7, requires those institutions to designate a "benefits navigator" to help students identify and determine their eligibility for various benefit programs.

Alzheimer's Care

Senate Bill 3707, signed May 27, requires all employees and people who work for agencies that contract with the Illinois Department on Aging who provide direct services to individuals participating in its Community Care Program to receive at least two hours of training in Alzheimer's disease and dementia, as well as safety risks, communication and behavior associated with

the disease. Hunting

Starting Jan. 1, deer hunters in Illinois will have a new option for the type of firearm they use. House Bill 4386, signed May 27, authorizes the use of single-shot centerfire rifles - guns that can fire only a single round of ammunition that contains primer in the center of the cartridge and not in the rim of the cartridge. Before, only shotguns, handguns and muzzleloading rifles

were allowed. **State Symbols**

Illinois will have two new official state symbols effective Jan. 1.

House Bill 4821 establishes the eastern milksnake as the official state snake. That was an initiative of Gentry Heiple, a snake enthusiast and Carterville Junior High School 7th

And House Bill 4261 establishes dolostone as the official state rock. That was an initiative of a group of students from Pleasantdale Middle School and Maplebrook Elementary School.





People who own vehicles that were manufactured in Illinois will be able to apply for a slight break on their registration fees starting Jan. 1. Senate Bill 3609 allows those drivers to apply for a one-time \$25 rebate, "if the vehicle is manufactured in this state and the application for title is made no more than one year after the month in which the vehicle was manufactured."

A-J, 5-8, advanced to play the winner of the Gallatin County-Massac County game in second-round action at the tournament.





You can help by reporting suspected drunk drivers to your nearest Illinois State Police headquarters.

From your cellular telephone or citizens band radio, provide the state police with the following information:

The location you are calling from. Time, location, direction of travel and a description of

the suspected drunk driver.

The make, color, and license plate number of the car.

Teen Drinking And Driving

Using a Fake Illinois **Drivers License or ID Card**

The penalties for using false IDs are serious and could change your life for-

Obtaining a drivers license through false affidavit is punishable by 1-3 years in prison and a maximum \$25,000 fine.

Allowing another person to use your identification documents to apply for a drivers license or ID card is punishable by one to three years in prison and a maximum \$25,000 fine.

Zero Tolerance Law for Possible imprisonment for Underage Drinking and **Driving**

Zero tolerance is a state law that went into effect on January 1, 1995. The law provides for suspension of the driving privileges of any person under the age of 21 who drives after consuming alcohol. Like the name zero tolerance suggests, any trace of alcohol in a young person's system can result in a suspended drivers license.

There are exceptions: minors who consume alcohol as part of a religious service or those who ingest a prescribed or recommended dosage of medicine containing alcohol.

Proper Action When Stopped By Law Enforcement Personnel

For the safety of vehicle operators and law enforcement, drivers stopped by police should adhere to the following suggestions:

Slow down and safely pull over on to the right-hand shoulder of the roadway.

If there is no shoulder or it is too narrow to pull over, find the next safest spot and pull over. Do not slam on the brakes

or stop in the lane of traffic. Drivers should not stop their vehicle on bridges, curves, next to guardrails, concrete walls, medians, or any place where it would be difficult for other vehicles to pass.

A vehicle should not be stopped too close to the solid white line, as oncoming traffic may strike it.

Stay in the vehicle with both hands clearly in sight on the steering wheel. Drivers should keep their hands on the steering wheel until the police officer instructs them otherwise or the traffic stop is complete.

Be prepared for the officer to approach from either the driver or passenger side of the vehicle.

Do not exit the vehicle unless asked to do so. Getting out of the vehicle can be perceived as aggressive behavior and a threat to the police officer's safety.

Comply with the officer's request to see a driver's license and proof of insurance. If these items are in the glove box or under the seat or if the proof of insurance is stored for display on a cellphone, the driver should inform the police officer of that fact and then follow the officer's directions before retrieving the information. Vehicle operators are required to have a valid driver's license, order to operate a vehicle.

If a driver cannot identify an unmarked police vehicle and/or the driver as law enforcement, he/she should drive slowly and carefully below the speed limit and either (1) pull over at a well-lit, populated location, (2) drive carefully to the nearest police station and attempt to attract officer or (3) call 9-1-1. A driver should activate the vehicle's hazard lights as a helpful way to communicate intentions with the police officer.

If a driver is being stopped at night, it is acceptable to turn on the interior light of the vehicle.

Atraffic stop could indicate the driver has committed a minor traffic violation without realizing it. There also may be a problem with the vehicle of which the driver is unaware or the vehicle may be similar to one used in a serious crime. Many officers will not provide the driver with specific reasons for the stop until they have obtained the vehicle registration, driver's license and insurance card from the driver.

If the traffic stop results in a ticket or arrest for the driver, he/she:

Should not debate the reason for the stop or argue with the police officer.

Should not refuse to sign a ticket if issued. Atraffic ticket requires the driver's signature. Signing a ticket is not an admission of the driver's guilt...only an acknowledgment of receiving the ticket.

Should not be uncooperative with law enforcement at the scene. If a driver is suspected of drunk driving, refusal to submit to breath, urine, blood or performance tests can result in the loss of driving privileges. Should not argue about the

ticket at the time of issuance. If a driver believes an offense was not committed or the ticket was issued unfairly, he/ she will have the opportunity to present the case in traffic court.

Should not resist arrest if taken into custody by the police.

A driver is to be treated with dignity and respect by law enforcement officers. If a driver believes that an officer has acted inappropriately during a traffic stop or other encounter, he/she should report the conduct as soon as possible to the officer's superiors. Officers are required

Regardless of what action is taken, police officers are legally required to document all traffic stops, which includes obtaining the driver's name and address for data collection purposes.





As always, we pray for those that are suffering through loss this time of


Any time is rough, but those first holidays without them are brutal, and we pray God grants them peace and comfort.







Cadet Class 139

The state commissioned 49 new troopers on Dec. 22 from Cadet Class 139 at a graduation ceremony at the Illinois State Police Academy in Springfield.

The total number of ISP troopers added since 2019 now stands at 417.

The new troopers were scheduled to report to 15 Illinois State Police patrol districts throughout the state on Monday, Dec. 26, and immediately began their patrol duties.

Among the assignments for the graduates were:

One of the cadets was assigned to Illinois State Police District 22 at Ullin. Three cadets were assigned to District 13 at Du Quoin.

One cadet was assigned to District 19 at Carmi

The Illinois State Police and one to District 12 at previous experience com-Effingham.

The governor's Fiscal Year 2023 budget for the Illinois State Police is the largest in state police history and allows for an additional 300 new troopers.

Cadet Class 139 was a Lateral Entry Training Program, LETP, class.

To be eligible for LETP, applicants must be a certified police officer having graduated from an accredited law enforcement academy and have at least two years of experience while employed as a fulltime sworn police officer.

"ISP is always looking for the best to join the ranks of one of the premier law enforcement agencies in the country," Illinois State Police director Brendan F. Kelly said in a news release.

'Cadet Class 139 consists of troopers who were law enforcement officers with other agencies. Their

bined with comprehensive training through the ISP Academy has allowed ISP to more quickly put experienced and highly trained troopers back into the communities from which they came."

LETP focuses on recruitment of current law enforcement officers to expedite the number of sworn troopers, which will provide increased safety to the citizens of Illinois.

The 49 newest troopers have completed a demanding 11-week program of physical and classroom instruction.

In addition to the 11week academy training, troopers are required to participate in one-on-one mentoring with field training officers as part of a 14-week field training program, expanding their total training to 25 weeks.

Troopers who successfully complete the field training program advance to solo-patrol status.

LETP condenses in-person training at the academy for prior law enforcement officers to five weeks with no more than three weeks in a row in

The cadets report to the academy for the first three weeks of the basic training program for an introduction into ISP cadet life.

The cadets then complete training at regional locations across the state with the ability to return to their residence at the end of each workday.

Cadets are required to return to the academy for specific trainings such as the emergency vehicle operations course.

Additionally, cadets graduating through the lateral program are not required to relocate their residence upon gradua-

The ISP Academy is one of the most respected and recognized training facilities in the country. Dozens of law enforcement agencies use the ISP Academy curriculum to meet standards set forth by the Illinois Law Enforcement Training and Standards Board. Earlier this year, the ISP Academy became the first Academy in the nation to adopt the National Association of the Advancement of Colored People "Ten Shared Principles."

Cadet Class 138

The state police also commissioned 42 new troopers from Cadet Class 138 at a graduation ceremony on Dec. 16 at the state police academy.

The new troopers reported to Illinois State Police District Chicago and District 11 at Collinsville on Monday, Dec. 19, and immediately began their patrol duties.

The 42 newest troopers have completed a demanding 28-week program of physical and classroom instruction.

In addition to the 28week academy training, troopers are required to participate in one-on-one mentoring with field training officers as part of a 14-week field training program, expanding their total training to 42 weeks.

Troopers who successfully complete the field training program advance to solo-patrol status.



Music director Dee Rose led the worship. Debbie York was the pianist.





Income, property tax rebates issued by state

State officials announced Dec. 21 that income and property tax rebates have been issued to over 5.1 million qualified taxpayers in Illinois. The rebates total \$1.042 billion.

The rebates were the result of the Illinois Family Relief Plan, passed by the General Assembly, which also provided grocery, gas and school supply tax savings.

The rebate payments, which were issued over the course of several weeks, were automatically sent to Illinois residents who filed 2021 state income taxes and claimed a property tax

Those who did not file, were still able to receive rebates after completing an additional filing.

Individuals who made less than \$200,000 in 2021 received \$50 income tax rebates.

Couples filing jointly with incomes under \$400,000 received \$100.

Tax return filers also received \$100 per dependent they claimed on their 2021 taxes, up to three dependents.

The State of Illinois also provided property tax rebates for eligible homeowners in an amount equal to the property tax credit they qualified for on their 2021 returns, up to a maximum of \$300.

The rebate was not allowed if a taxpayer's adjusted gross income for the taxable year exceeded \$500,000 for returns with a federal filing status of married filing jointly, or \$250,000 for all other re-

The State of Illinois also provided property tax rebates for eligible homeowners in an amount equal to the property tax credit they qualified for on their 2021 returns, up to a maximum of \$300.

The rebate was not allowed if a taxpayer's adjusted gross income for the taxable year exceeded \$500,000 for returns with a federal filing status of married filing jointly, or \$250,000 for all other re-

The Illinois Department of Revenue, IDOR, certified the list of eligible taxpayers, and the rebates were issued by the comptroller's

Rebates were sent automatically using the same method original refunds were transmitted if they were sent directly to the taxpayer by the State of Illinois.


Though the 2021 tax deadline was April 18, all qualified taxpayers who filed by Oct. 17, 2022, were eligible for rebate payments.

Less than 4 percent of qualified taxpayers may still be awaiting their rebates. This includes taxpayers who filed their state income tax returns later in the year, and those currently having to respond to IDOR inquiries regarding their rebates.

Energy markets expected to remain uncertain

U.S. consumers have seen some relief at the fuel pump in recent weeks.

Nationwide, average weekly prices for diesel fuel declined from \$5.21 Nov. 21 and \$5.14 Nov. 28 to \$4.96 per gallon Dec. 5.

The average weekly price of regular gasoline during the same period declined from \$3.64 and \$3.53 to \$3.39 per gallon, the U.S. Energy Information Administration, EIA, reported.

But prices were still up \$1.29 per gallon for diesel and 5 cents for gasoline during the first week of December compared to last year.

So, what can consumers expect through the month and into next year?

"We expect the combination of a slight contraction in the U.S. economy and refinery maximization of distillate fuel production will reduce distillate prices," EIA noted in its short-term energy outlook released Dec. 6.

"However, the EU's ban on seaborne imports of petroleum products from Russia creates supply and

price uncertainty to distillate markets in early 2023."

The markets also must contend with a recent decision by OPEC to maintain crude oil output cuts of 2 million barrels per day, or about 2 percent of world demand.

The purpose of the move is to boost the global price of oil, which has fallen recently on fears of demand weakness, particularly in China, according to AAA, the Auto Club Group.

"Gas prices are dropping sharply and are only a nickel more per gallon than a year ago," said Molly Hart, AAA spokesperson.

"But, with oil being the main ingredient of gasoline, OPEC's move could slow this decline. However, the gas price will likely soon be lower than it was a year ago."

EIA projects global oil inventories could decline by 200,000 barrels per day the first half of 2023 before rising nearly 700,000 barrels per day the second half of the year.

The forecast leaves global oil inventories higher at the end of 2023 than previously projected, which results in a

current price forecast of \$92 per barrel for Brent crude oil in 2023, down \$3 from the

November estimate. The projection of higher winter heating demand mixed with tight supplies of some fuels could boost the cost for U.S. citizens to heat their homes and businesses this winter, along with other electrical needs.

"Winter energy expenditures for most households likely will be higher than last winter. Expenditures could be much higher if the weather is very cold," EIA noted in its winter fuels outlook.

EIA estimates winter expenditures could rise by an average of 28 percent for natural gas, 27 percent for heating oil, 10 percent for electricity and 5 percent for propane this season compared to last year.

Total winter expenditures account for all costs, not just home heating, from October through March.

"We expect natural gas

prices to increase from November levels as a result of both higher winter natural gas demand and rising exports," EIA reported in its

short-term outlook. "We expect natural gas prices will begin declining after January as U.S. storage levels move closer to the previous five-year average.'

The highest projected electricity prices for this winter are in New England, due in part to capacity constraints on pipelines delivering natural gas into that region.


Nationwide, almost 90 percent of homes are primarily heated with natural gas or energy. The use of heating oil and propane is more regionally concentrated.





He Who Shall Be Blessed: James 1:21-25

In the book of James, the apostle addresses important

Christians concepts. Verses 2-18 speak of how to face temptations, and verses 19-27 discuss how to hear and follow the Word. In verse 18, James reminds Christians to be the "first fruits" of HIS creation, and verses 19-21 instructs on how to accomplish this task.




Lotrell Hileman

Montgomery Village, Md. - Barbara A. Dye. 90, died peacefully on Dec. 13, 2022, at Shady Grove Hospital.

She was born on March 19, 1932, in Anna, Illinois, the daughter of Thomas and Helen Meisenheimer, deceased.

Barbara had an interesting, varied, and for a time, secret

Shortly after graduation from high school she was

interviewed by a recruiter from the Central Intelligence Agency, CIA. She accepted their offer and was trained by the CIA as a cryptographer.

In 1953, she was assigned to a very sensitive program in Germany and was the youngest woman ever assigned to such a program.

She was the sole cryptographer for the CIA team assisting the new German Intelligence Service. This was at the height of the Cold War and the threat of communist expansion into democratic Europe was a real threat.

Barbara was required to live under cover and many times had to travel behind the Iron Curtain under fictitious

In 1956, she returned to CIA headquarters and met her future husband, Louis E. Dye, also an CIA employee. They were married in 1959 and later assigned to a small town in Iran near the Russian border.

In Iran, while pregnant and alone, she survived the worst earthquake in the history of Iran. Later, she narrowly escaped a bloody street riot which threatened her and the new baby boy.

In 1964, Barbara resigned from the CIA to care for her family as they were assigned to programs in Florida and California. In 1971, the family moved to Montgomery County, Md., and Louis continued working for the CIA.

Barbara used her natural charm and intelligence to develop a career in real estate and was successful for 38 years.

She was also very active with the county regulatory associations. She served on the following County Board of Realtors committees: chairman of the Sales Award, Finance, Professional Standards and Grievance.

She was also active in the Montgomery County Heart and Cancer charities, helping to organize fund raising activities and events.

Southern 7 offers winter safety tips The region experienced bitter cold temperatures and-

The region experienced bitter cold temperatures andsnow during the past week. With the arrival of winter weather, Southern 7 Health Department says that it's time for area residents to prepare for the potential hazards that come with it.

The health department is sharing some basic steps people can take to safely weather the storms.

Heat your home safely. Furnaces should be inspected prior to use and always follow the manufacturer's instructions. Check local fire codes for your area if using a fireplace, space or kerosene heaters.

Generators, gas or charcoal grills, camp stoves or similar devices should be used following all manufacturer instructions.

Never use any of these devices indoors. Each can produce fumes that can be deadly, so make sure to install a battery-powered carbon monoxide, CO, detector in your home. Do not use a generator or any appliance if they are wet.

Should you lose your primary heat source for any reason, do not turn on the stove for heat but instead bring out extra blankets, sleeping bags and warm winter coats.

Conserve heat by avoiding unnecessary opening of doors and windows, close draperies or cover windows with blankets at night and close off unneeded rooms.

Remember that babies and older adults may not be able to maintain body heat effectively. Consider staying elsewhere if heating your home becomes an issue.

Keep your home well-lit to avoid injuries. Use battery-powered flashlights and lanterns during a power outage avoiding candles, if possible. Never leave lit candles unattended.

Make sure to dress warm with layers, stay dry and eat well-balanced meals if you're planning to venture outdoors.

Alcoholic and caffeinated beverages cause your body to loose heat faster, so instead chose warm, sweet beverages or broth to keep yourself warm. Talk to your doctor about any dietary restrictions you may have.

When you're outside, always watch for signs of hypothermia, frostbite and over exertion in yourself and others. Let someone know when you are going outdoors and when you plan to return.

If you are traveling, let others know your plans and check weather reports and travel conditions frequently. Always carry extra warm clothing and blankets in your vehicle, and keep your phone charged.

If you become stranded, stay in your car until help arrives. Run the motor and heater for about 10 minutes per hour, opening one window slightly to let air in to avoid CO poisoning.

Broadband critical tool for rural health care

Shirley Bloomfield sees an opportunity for a rural renaissance. But access to health care is vital.

The NTCA-Rural Broadband Association CEO discussed the intersection of rural health and broadband during a recent webinar organized by the National Organization of State Offices for Rural Health.

The event, titled "Collaboration Carpool: Conversations with Mission-Minded Rural Stakeholders," included multi-sector experts who discussed collaboration efforts to improve health for the nearly 61 million people living in rural America.

"I think broadband can be a really critical tool as we think about ways to augment, supplement, support existing health care," Bloomfield said.

He added that approximately 60 percent of the 7,200 federally designated health care provider shortage areas are in rural communities.

And thanks to ongoing initiatives, including the federal infrastructure bill that allocates \$65 billion for the expansion of broadband, now is the ideal time to call attention to the connection between rural health care and broadband, she said.

During the pandemic, telemedicine quickly became a critical piece of health care, with mental and behavioral health care the fastest-growing sector.

"The ability to offer health care and mental health support and substance abuse support to people where they live and where they are comfortable is going to be extremely important," she said.

Along those lines, Bloomfield highlighted a grant program initiated by the Foundation for Rural Service – the Virtual Living Room.

The program blends rural technology, U.S. Department of Veterans Affairs resources and local support to encourage veteran use of advanced medical technologies.

Virtual Living Room saves veterans travel time and costs while enabling connections to skilled physicians and other providers in the VA medical system such as telehealth and other online resources.

"The grant is used to create a safe space in a local library, community hall, a local Rotary Club, we have them set up everywhere," she said.

"These aren't complicated, but they allow the ability to create that safe space, that access to care, that instantaneous service that rural Americans are looking for."
