State facing potential \$3.2 billion budget shortfall

The first extensive public look at next year's state finances contains a warning to lawmakers from the governor's office: "The ability to fund new programs will be severely limited" next fiscal

That comes from the Governor's Office of Management and Budget, GOMB, which projected a potential budget shortfall of \$3.2 billion for fiscal year 2026, which doesn't

begin until July 1.

The Illinois Economic and Fiscal Policy Report published each November is often seen as a table-setter for the budgeting negotiations that will ramp up in earnest when lawmakers return to the Capitol for the legislative year that begins each January.

GOMB projects that revenues will remain flat at roughly \$53.4 billion for the upcoming year, while spending will grow by \$3.2 billion.

While the overall num-

bers can change quickly in the eight months between now and the start of fiscal year 2026, the report could forebode an even more challenging budget process than the one that wrapped up in May. Lawmakers entered last year's session staring down a roughly \$891 million deficit, according to last year's GOMB report.

After lengthy and sometimes fraught deliberations, Democrats in power narrowly approved a budget that filled the gap by extending a cap on corporate net operating losses (\$526 million), capping a tax discount claimed by retailers (\$101 million), increasing the state's tax on sports betting (\$200 million) and other smaller accounting measures or tax changes.

As for the impending \$3.2 billion deficit, the report noted only it "will be addressed in the Governor's Fiscal Year 2026 Introduced Budget."

But, the report noted, spending reductions "can-

not be implemented broadly across-the-board," especially for the 40 percent of spending that is mandated either by court order, law or other obligations, such as debt service, pension payments and Medicaid. Another 24 percent of state spending goes to areas such as education and higher

The expected deficit is attributable in part to both rising expenditures and revenue (continued on page 2)

education.

State Lottery sets record

As it celebrates its 50th

anniversary, the Illinois Lottery announced Oct. 31 that it is also celebrating another record-breaking year of sales and returns to the State of Illinois.

The Illinois Lottery is reporting sales of \$3.86 billion and lottery proceeds of \$883.6 million, which are both higher than the previous year.

Fiscal year 2024 was notable for having five multi-state jackpots over \$1 billion for the first time in lottery history.

These five large jackpots figured prominently in the Lottery's performance for 2024, marking the third consecutive year of record sales and returns to support the Common School Fund and other good

From May to October of this year, the Illinois Lottery was celebrating its 50th year by introducing a family of Instant tickets named Celebration with second-chance drawings. of the House Veterans Affairs Committee.

Bost said the legislation makes historic investments in enhancing veterans' healthcare and benefits, improves caregiver support and reduces barriers for veterans to access

"From mental health services to caregiver support, this legislation tackles some of the most pressing issues facing veterans today," Bost said in a news release on Monday, Nov. 18.

"It expands job opportunities, strengthens community care programs, and gets veterans out of homelessness.

"Most importantly, it focuses on putting veterans at the center of the VA system. I'm proud to work alongside my colleagues in the House to advance this critical bill and I urge the Senate to pass it swiftly. Our veterans and their families deserve nothing less."

The Senator Elizabeth Dole Act has been endorsed by more than 50 leading veterans service organizations, including the Disabled American Veterans, the Veterans of Foreign Wars and the Paralyzed Veterans of America.

The legislation also includes key provisions for survivors and improves mental health services for veterans and their caregivers.

This bipartisan effort marks a significant step forward in ensuring the VA meets the needs of today's veterans in Southern Illinois and across the United States, Bost said.

State budget

(continued from page 1) stagnation as some one-time sources disappear.

The projected spending for Fiscal Year 2026 includes an additional \$350 million to K-12 education, while pension costs are expected to increase by \$440 million among other "moderate growth" in state spending across the board.

Health care costs are expected to grow by \$1.1 billion, due in part to "the impact of medical inflation and drop off of one-time FEMA (Federal Emergency Management Agency) reimbursement revenues" for Medicaid and state health care plans. FEMA had still been reimbursing some pandemic-era costs borne by state government, according to the governor's office, but that's expected to drop off in the upcoming fiscal year.

Revenues are expected to stagnate in part because of a "true-up" process at the Illinois Department of Revenue that has temporarily inflated state coffers over the past two years, stemming from a complicated miscalculation by the department.

In short, IDOR overdistributed the amount of money collected in Corporate Property Replacement Taxes, which primarily go to local governments, in tax year 2021 by about \$800 million. Corporate income taxes were overestimated by \$200 million, while individual income taxes from pass-through entities were underestimated by \$1.1 billion. The miscalculation, according to IDOR, "was caused by tax policy changes," at the federal and state level affecting businesses. The department began a

"true-up" process in fiscal years 2024 and 2025 that is aimed at fixing the "overpayments" to local governments while boosting state general revenues in the process.

It's had the effect of driving general revenues up by about \$1 billion in each of fiscal years 2024 and 2025.

But the same won't hap-

pen in Fiscal Year 2026, the

legislature's Commission on

Government Forecasting and Accountability noted in its September report, because IDOR adjusted its disbursement percentages in 2023. As a result, COGFA noted,

general fund receipts could be "notably weaker" in the upcoming fiscal year, and GOMB's report indicates the

Revenues are also expected to slow as the Federal Reserve decreases interest rates, lowering the state's investment

The state is also entering the final step of a five-year process of shifting the sales tax collected on motor fuel from the General Revenue Fund to the Road Fund. That shift was included in Pritzker's first budget in 2019 as part of the Rebuild Illinois infrastructure plan.

Still, the report projects about \$1 billion combined growth in corporate and personal income tax, while sales taxes are projected to fall by \$330 million, marking a mixed bag for the state's "big three" revenue sources.

A History of Surpluses

What comes of the projected deficit and how it is defrayed will be up to the governor and the new General Assembly that is seated in January.

Thus far in his tenure, Pritzker's administration has shown that it can work with lawmakers to balance the books. Every year since the COVID-19 pandemic upended state finances in 2020, the state has seen significant surpluses. Those occurred for several reasons, including better-than-expected revenues as consumers spent more on goods, and government stimulus checks that boosted the economy.

Some years have been buoyed by one-time factors, such as the "true-up" process of the past two years and the state's retroactive collection of Medicaid dollars in fiscal

year 2024. But the surpluses are also partially attributable to the

Pritzker administration's con-

servative estimates early in the budgeting process. In past years, that allowed lawmakers to kick extra revenues to the state's "rainy day" fund that now has a record balance of \$2.2 billion while paying down about \$11 billion worth

of outstanding debts. Late payment interest expenditures have dropped from about \$980 million at the height of the state's two-year budget impasse between Republican Gov. Bruce Rauner and Democrats in the General Assembly in fiscal year 2018, to \$137 million in Pritzker's first year in office and \$13

million last fiscal year. The forecast from GOMB anticipates a surplus for the current year as well, prior to next year's deficit. Personal income tax and interest income have been higher than expected, while corporate income taxes are coming in lower than originally project-

All told, the state is now looking at a \$262 million current-year surplus, according to the report, but \$246 million of that would be reserved in the Budget Stabilization, or "rainy day" fund.

October weather in region warmer than normal, unusually dry

October was dry and warm in the Southern Illinois, Southeast Missouri and Western Kentucky region.

The National Weather Service office in Paducah shared a climate review for the month on its website.

Temperatures

The month of October averaged 2 to 4 degrees above normal.

High temperatures some 5 to 6 degrees above normal were somewhat offset by low

temperatures that were near average.

This was largely due to very dry air, which allowed for wide temperature swings from chilly morning lows to warm afternoon highs on a number of days.

The warmest part of the month occurred during the first week, when high temperatures at many locations reached the upper 80s to near 90 degrees.

The first widespread frost occurred by the middle of the month, when low temperatures dropped into the upper

20s and lower 30s. **Precipitation**

Even for October, the month was unusually dry. In fact, October was on track to be one of the top driest months on record until rain finally arrived by the end of the month.

Even with the rain that fell on Halloween, most of the forecast area received less than an inch of rainfall for the

entire month. Local weather observer Dana Cross recorded only 0.96 of an inch rain for the month near Jonesboro.

In the end, October 2024 turned out to be the sixth driest on record at Paducah and eighth driest at Cape Girardeau and Carbondale. It was also the ninth warmest

Illinois to receive \$40 million share of opioid settlement

CHICAGO - Illinois will receive a \$40 million share of a \$1.4 billion bipartisan national settlement with Kroger over the grocery chain's role in the opioid crisis, Illinois Attorney General Kwame Raoul announced.

The settlement is the latest contribution to the 2021 Illinois Opioid Allocation Agreement steered by Raoul and state's attorneys.

"This settlement ensures Kroger is held accountable and allows resources to reach communities hardest hit by this ongoing opioid crisis that continues to affect all corners of America," Raoul said in a Nov. 4 statement announcing the settlement.

Under the agreement Kroger will also require its pharmacies "to monitor, report and share data about suspicious activity related to opioid prescriptions," the statement said.

The agreement will only be applicable to states in which Kroger and its subsidiaries operate, according to the statement, noting that in Illinois, Kroger operates under the Kroger name as well as Mariano's and others.

By 2038, Illinois' Opioid Remediation Fund is projected to receive approximately \$772.6 million in total from various opioid manufacturers and distributors, according to the settlement fund allocation dashboard operated by the Illinois Department of Human Services.

Illinois was awarded more than \$420 million from Johnson & Johnson, Walmart, Walgreens, Allergan, CVS, Teva, Mallinckrodt, and opioid distributors, such as AmerisourceBergen, Cardinal Health and McKesson.

Since Gov. JB Pritzker signed Executive Order 2022-19 in 2022, funds received from any settlements will be distributed into three

communities; 25 percent will be awarded to local governments to provide their own abatement programs, and the remaining 20 percent will go to the state to carry out abatement programs through the Illinois Department of Public Health.

To date, Illinois has committed or spent \$115 million from the fund, according to the Illinois Opioid Settlement website.

Most of the money has been awarded to organizations that have applied for funding to implement opioid abatement programs in their

The Illinois Opioid Remediation Advisory Board is the governor-appointed body that is responsible for making advisory recommendations for how the Illinois Opioid Remediation Trust Fund will be spent.

State Rep. La Shawn Ford, D-Chicago, was appointed by the governor to serve on the board, along with organizations that represent the needs of the entire state. In an interview, Ford said he has dedicated a lot of his time to this issue.

"Lt. Gov. Juliana Stratton brought grassroots organizations to the advisory board, allowing them to have input on how the money is being spent, which is critical, when you have people, organizations, nonprofits doing the work and having a say in how the settlement funds are spent," Ford said.

All programs and funding priorities must align with strategies described in the 2021 agreement, including: naloxone or other overdose reversal drugs; medication-assisted recovery and other recovery or bridge services; services for pregnant of postpartum people with opioid use disorders, as well as neonatal abstinence syndrome; treatment for incarcerated people; syringe services; prevention programs; harm reduction programs;

and syringe services. According to Ford, once recommendations are made by the advisory board, they will be forwarded to Raoul's office for approval to ensure that the programs align with the priorities set in the settlement agreement.

IDPH: COVID, flu, RSV typically surge in fall, winter

The Illinois Department of Public Health, IDPH, is reminding the public that fall brings the start of the traditional respiratory virus season.

The department is urging Illinoisans to use the proven tools that can safeguard them from illnesses that typically surge during the fall and winter, including COVID-19, flu and RSV. This includes getting vaccinated for those viral diseases for those who are eligible.

The department has upgraded its Seasonal Respiratory Illness Dashboard and has posted two new FAQ documents on its website providing the latest guidance on vaccinations and how to get tested and treated for these seasonal illnesses.

In addition, the CDC has created a new Respiratory Illness Data Channel that provides nationwide county specific information that would valuable for anyone planning to travel out of state, IDPH said.

"As we head into fall, the Department of Public Health is closely monitoring this season's respiratory illnesses and so can you with our updated respiratory illness dashboard," IDPH director Dr. Sameer Vohra said in a news release.

"Similar to past seasons, we should expect a rise in RSV, COVID-19 and flu cases as the weather cools. Now is a great time to get yourself protected from severe illness with updated vaccines, especially if you are over 65, immunocompromised or have chronic medical conditions."

Public health leaders also stress that one of the best ways to reduce transmission of viruses is to stay home when you are sick to reduce transmission

Anyone with respiratory, symptoms, such as coughing, a runny nose or fever, should try to self-isolate from others, unless they need to seek medical care. If you cannot self-isolate, wear a well-fitted mask around others.

IDPH officials remind the public that there are effective anti-viral treatments available for COVID-19 and the flu, but they must be started quickly. This is why it is important to get tested if you are feeling symptoms.

For COVID-19, treatment must be prescribed by a healthcare provider and started within five to seven days after symptoms appear. Treatment is strongly recommended for those who are over 65 or at higher risk for severe illness. Some Illinoisans should be eligible to access free oral antivirals through the Paxcess and Merck Helps programs.

Antiviral treatments for flu are most effective when given within 48 hours of starting to feel ill and are only available by prescription.

Older adults, young children and those who are pregnant or have conditions like diabetes, asthma and heart disease are at risk for complications and should contact a healthcare provider be assessed for the need for treatment as soon as possible, IDPH advised.

You can find locations that perform COVID-19 tests in person at no cost near you by using the testing locator for the federal ICATT (Increasing Community Access to Testing) program. In addition, the federal government resumed offering free COVID tests to every household through the covidtests.gov website.

The IDPH respiratory illness dashboard showed that hospital admissions for COVID-19 were trending down and were at 1.4 percent. of admissions, according to data as of Sept. 28. Illinois' overall respiratory illness level was listed by the CDC as minimal.

The FDA and CDC have approved new vaccines for this fall for COVID-19 and flu, as well as updated who can receive the RSV vaccines.

The new COVID vaccines and the new flu shots are recommended for everyone over the age of 6 months.

The RSV vaccine is recommended for everyone 75 years and older. But if if you got an RSV shot last winter, you do not need another at this time, according to the CDC.

Those in the late stages of pregnancy are advised to get the RSV vaccine designed to protect newborns. Newborns whose mothers have not received the RSV vaccine, should receive nirsevimab between

October and March. The new vaccines are widely available at pharmacies and through hospitals, and community health clinics. The major pharmacy chains allow you to make an appointment to get a shot online. For help finding a provider of vaccines near you, go to www.vaccines.gov.

For those who don't have healthcare coverage through a private plan, Medicare or Medicaid, IDPH operates the Vaccines for Children Program. which provides vaccines at no cost for children 18 and under.

Adults without insurance have several options. They can check with their local health department or contact a free and charitable clinic or a community health center.

2 cups canned pumpkin 1 teaspoon vanilla extract

1/2 teaspoon baking pow-


Invert cake onto rack for cooling after 8 minutes.

He graduated from Cobden High School in 1962. He served his country as second lieutenant in the National Guard for many years.


He had a long career in construction, owning his own construction business. Alongside his construction business, he also owned a lumberyard and farmed beef cattle.





Student advisory council meets

State Sen. Dale Fowler, R-Harrisburg, welcomed an estimated 70 high school students from 14 schools to Mountain Dew Park in Marion on Oct. 30 as part of his annual Student Advisory Council.

'I look forward to hosting this event every year and bringing students from all over the 59th Senate District together for a conversation on state government, leadership and the importance of having a voice," Fowler said in a news release. "I'm always so impressed by the students and their willingness and desire to be involved, learn more and embrace the idea of being future leaders in their communities."

Fowler's Student Advisory Council is a hands-on experience designed to teach local area students about public policy, state government and leadership. Each high school in the 59th Senate District in Southern Illinois nominated high school students who have shown an interest in government and public service.

In the morning, students heard from successful community leaders, including Russell Williams, founding director of EThOs at the Citadel; TW Norman, lead pastor at Little Chapel Church; and Rodney Cabaness, owner of Black Diamond.

Students then broke into groups, where they were asked to work together to develop ideas for possible new state legislation to present to the full Student Advisory Council. Fowler spent time during the group discussion with each small group, helping students with their proposals and offering advice on how they could advocate for their issues.

When the students presented their ideas, Fowler helped spur further debate by facilitating questions to the groups about their legislation. The students voted to choose one of the proposals to take up in a mock committee hearing at their next meeting, which is scheduled in the spring at the State Capitol in Springfield.

Be cautious: fall is time to watch for deer along roads

While accidents can happen at any time of year, most deer-vehicle incidents occur between dusk and dawn during the months of October, November and December.

Drivers should slow down and stay alert to avoid deervehicle collisions this fall when traveling after dark.

Not all deer-vehicle accidents can be prevented, but drivers can reduce their chances of a collision by understanding basic deer behavior and being proactive.

Illinois deer hunting season is underway through mid-January, so deer are on the move more, says Peggy Doty, a University of Illinois Extension educator in energy and environmental stewardship.

"White-tailed deer are crepuscular, which means they are most active during dusk and dawn," Doty says. "In addition, harvest is happening in some parts of the state, which removes many acres of cover for the animals, forcing them to be on the move."

At 100 to 250 pounds, white-tailed deer are Illinois' largest mammal, according to the Illinois Department of Natural Resources website Wildlife Illinois.

The largest populations of deer in Illinois are in wooded areas in watersheds of the major rivers, especially the Mississippi, Rock, Illinois and Kaskaskia rivers and in the Shawnee Hills in Southern Illinois.

Doty offered some tips for motorists. When driving at night, reduce your speed, keep a safe distance from other vehicles and be prepared to stop.

Watch out for deer in areas where they have been spotted in the past. Deer crossing signs are an indicator of this but roadways close to woodlots, field edges or water also require extra caution.

Scan roadsides for "eyeshine," which is the reflection of headlights in the deer's eyes, and use high-beam lights when appropriate.

If a deer crosses the road,

slow down; there may be more deer or they might double back. Alert other motorists to the presence of deer by tapping your brakes or using emergency flashers.

Avoid slamming on the brakes or swerving into traffic or off the road if deer are on the roadway. This can cause a loss of control of the vehicle.

Instead, slow to a stop and wait for the deer to move. Flash your headlights and honk the car horn in short bursts to encourage deer to move off the road.

If a deer is struck, safely pull off the road and assess the situation. Call 911 if the deer is injured. It is illegal for anyone except a law enforcement officer to kill a crippled deer.

Deer killed from a vehicle collision legally can be claimed by any Illinois citizen. Claims must be reported within 24 hours by calling 217-782-6431 or online at deer.wildlifeillinois.org.

Fall firearm hunters harvest 292 wild turkeys in Illinois Turkey hunters in Illinois year, compared to seven last harvested 292 wild turkeys year. Massac County: five this year, compared to two

during the 2024 fall firearm season Oct. 19-27.

The harvest total was up 10 percent from 2023, the Illinois Department of Natural Resources, IDNR, reported.

The record harvest was set in 2005, when 1,218 birds were harvested.

This year, 1,756 regular fall firearm season permits were sold, compared to 1,771 last year, IDNR reported. The largest number of permits sold was in 2007, when hunters purchased 4,968 permits.

Fall firearm turkey hunting was open in 56 of Illinois' 102 counties.

The top counties for harvest this year were Jefferson, 17; Jasper, 16; Marion, 16; Jo Daviess, 13; and Cass, 12.

Preliminary data show 57 percent of the harvest were female birds, while 43 percent were male.

Alexander County: four this year, compared to four last year. Jackson County: 10 this year, compared to four last year.

Johnson County: six this
